# EXPONENTIALLY-TAILED REGULARITY AND DECAY RATE TO EQUILIBRIUM FOR THE BOLTZMANN EQUATION

#### Abstract

After revisiting the existence and uniqueness theory of solutions to the homogeneous Boltzmann equation whose transition probabilities (or collision kernels) [32, 4] are given by Maxwell type and hard intramolecular potentials, under just integrability condition for the angular scattering kernel, we present in this manuscript several new results. We start by showing the Lebesgue and Sobolev propagation of the exponential tails for such solutions. Previous results required stronger angular scattering kernel integrability conditions [5, 25]. In addition, we show new estimates giving $L^{p}$-integrability generation of such tails in the case of hard potential interactions in the range $p \in[1, \infty]$, exponentially-fast convergence rate to thermodynamical equilibrium (under rather general physical initial data), and regularization in the sense of exponential attenuation of singularities. Novel contributions also include, the propagation of fractional Sobolev exponential tails using pointwise (i.e. strong) commutators between fractional derivatives and the collision operator, and the analysis for the critical case of Maxwell interactions corresponding to propagation of tails rather than generation. In many ways, this work is an improvement and an extension of several classical works in the area [5, 11, 15, 25, 35, 39]. We, both, use known techniques and introduce new and flexible ideas that achieve the proofs in an rather elementary manner.

## 1. Introduction

We study qualitative and quantitative aspects of the $L_{\text {exp }}^{p}$ exponentially weighted Lebesgue integrability, propagation and generation, in the sense of tails, and the $H_{\text {exp }}^{k}$ exponentially
weighted Sobolev, propagation for the homogeneous Boltzmann equation with hard potentials and Maxwell molecules for integrable angular scattering kernel. In addition, we study the exponentially fast asymptotic convergence of solutions towards thermodynamical equilibrium under general physical initial data, propagation of regularity using pointwise (strong) commutators between the collision operator and fractional differentiation, and exponential attenuation of singularities. The proof is valid for any dimension $d \geq 2$, integrability $p \in[1, \infty]$, regularity $k \geq 0$, and integrability assumption on the scattering kernel. More precisely, the scattering kernel is assumed to have the form

where we can set, without loss of generality, $\|b\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}=1$. When the dependence of the angular scattering kernel $b$ is important, say in the constants involved in the estimates, it will be explicitly stated. We note that the support of $b$ is assumed to be in $[0,1]$ thanks to a symmetrization argument (thus, $b$ is assumed to be symmetrized [25, pg. 3]). Throughout the paper, we use the notation $Q_{\gamma, b}(f, f)$ to refer to the collision operator corresponding to such scattering kernel unless it is clear from the context. In the latter we simply write $Q(f, f)$. We recall the definition of such operator

where the collisional variables are defined as

The scattering angle $\theta$ is simply defined as $\cos (\theta):=\hat{u} \cdot w$. Unitary vectors will always be denoted as $\hat{u}:=u /|u|$. In this way, the homogeneous Boltzmann equation simply writes

The initial data considered in this document is nonnegative and has finite mass and energy,

moreover, without loss of generality we can set the initial mass equal to unity. In this case, equation (1) has a unique solution $f(t, v) \geq 0$ that conserves initial mass, momentum and energy, see [32].

We will commonly use, for technical reasons, the decomposition of the angular scattering kernel to estimate distinct parts of the collision operator

Before starting with the technical details, let us mention that propagation of $L^{p}$ integrability for the Boltzmann equation, with different degrees of cut-off and weights, has been studied for quite some time now. In the case of polynomial weights, classical papers for the hard potential case are $[19,11]$ for $p=\infty$. The case $p \in(1, \infty)$ has been studied in $[30,35,23]$ and $p=1$ in [32, 22], while the Maxwell molecules model for the whole range $p \in[1, \infty]$ is studied in [40, Prop. 1.4]. In particular, the $L^{\infty}$-norm propagation has been shown for $b$ assumed bounded. Interestingly in all these works, entropy plays a subtle role in the argument: it is used to find a suitable a priori uniform lower bound for the loss collision operator. In fact, we show that for hard potentials entropy will not play such a relevant job as far as propagation of $L^{p}$-norms is concerned, instead, the propagation of a higher moment will be key. Yet, for the Maxwell model, it plays a central part when estimating the gain collision operator in a suitable way.

The propagation of exponentially weighted norms is more rare in the literature, however, reference [25] is an illuminating example of it, where pointwise gaussian estimates are shown to be propagated in the case of hard potentials using a comparison principle. These techniques have been applied later for the Maxwell case in [15] after nontrivial modifications. Again, the assumption of the angular function $b(\cos \theta$ bounded is present in all these cases. Exponentially weighted $L^{1}$-norms are well understood in all cases and have been extensively studied in $[13,25,33,2]$ for $\gamma>0$ and in $[13,15]$ for $\gamma=0$.

For previous results on propagation of Sobolev norms we refer to [35] with polynomial weights, and [5] with gaussian weights. These references are restricted to the hard potential case with cut-off condition $b \in L^{2}\left(\mathbb{S}^{d-1}\right)$. For the Maxwell molecules model, the propagation of smoothness and its relation with the relaxation towards equilibrium is studied in [21]. In this document, the analysis of propagation of regularity and relaxation are independent giving a more robust and general approach.

One of the main contributions of the present document with respect to $L^{p}$-integrability and propagation of Sobolev norms is to unify all previous works with a relatively simple line of reasoning that includes all ranges of integrability $p \in[1, \infty]$ and weights, polynomial and exponential, including gaussian. It also includes both, Maxwell and hard interactions. Another novelty of our paper is that we extend the range of $p$ for the propagation of $L^{p}$ exponentially weghted norms from $p=1$ and $p=\infty$ to the entire range $p \in[1, \infty]$. We also relax the assumption on the angular kernel for the $L^{\infty}$ results by asking that the kernel is merely integrable (as opposed to being bounded in the previous works). Finally, in the context of Sobolev norms we relax the assumption from $b \in L^{2}\left(\mathbb{S}^{d-1}\right)$ to $b \in L^{1}\left(\mathbb{S}^{d-1}\right)$, we are able to prove propagation of fractional regularity by introducing pointwise commutators between fractional differentiation and the collision operator, and we consider Maxwell molecules.

The program to prove Lebesgue exponential tail propagation/generation consists in 3 main steps, (1) prove propagation/generation, respectively, of exponential moments [13, $14,16,2,36]$, (2) prove a so-called "gain of integrability" inequality for the gain collision operator in the spirit of $[35,6]$ and, (3) use Young's inequality $[30,3]$ for the gain collision operator to deal with the case $p=\infty$. In addition to these main steps, we will need
an explicit lower bound for the negative part of the collision operator which seems to be classical in the literature, at least when finite initial entropy is assumed, see Lemma 2.1 below. Contrary to the hard potential case, the critical case of Maxwell interactions will need the a priori propagation of entropy. That is, the additional assumption

will be required on the initial condition. This is harmless in our context since we will impose more restrictive conditions on $f_{0}$, namely, $f_{0} \in\left(L_{2}^{1} \cap L^{p}\right)\left(\mathbb{R}^{d}\right)$ for some $p>1$, when proving propagation of Lebesgue norms.

Let us finish this short summary saying a few words about the relaxation to thermal equilibrium of solutions to the Boltzmann equation. The literature is ample in this respect, notable examples are $[12,33,35,39,21]$ and the references therein. It is well established that such convergence will occur with exponential rate in $L^{p}$-norms, even Sobolev norms, provided enough regularity is satisfied by the angular scattering kernel and the initial data. This holds also for the case of Maxwell molecules [21] for initial data with enough tail decay and regularity. In all aforementioned references such angular scattering kernel must be at least bounded and the initial condition is usually taken at least in $L^{2}\left(\mathbb{R}^{d}\right)$. In references $[12,39]$ a clever approach is introduced using a dyadic splitting of the collision operator. In $[33,35]$ the analysis relies on the decomposition theorem, that is, propagation of smoothness and roughness, and the entropic methods, see for instance [38]. In both approaches spectral theory is also key, in particular, reference [33] introduced a powerful quantitative technique known as enlargement of the spectral functional space.

The contributions of this document in this topic is given, for hard potentials, in terms of the requirement of the scattering angle kernel and the generality of the initial data. In particular, we will only assume

The strategy follows the entropic methods. One of main contributions is the relaxation of the result given in [38] with respect to the dissipation of entropy for hard potentials. This will allow us to prescind of the decomposition theorem. This is important since the most general proof of the decomposition theorem available requires $b \in L^{2}\left(\mathbb{S}^{d-1}\right)$, see [35]. Once this is achieved, the result will follow after a fine decomposition of the Boltzmann linearized operator and the spectral enlargement result given in [29]. As an application of this convergence result, we prove the decomposition theorem under just assumptions (4) and (5).
1.1. Outline of the paper. In Section 2, we list several lemmas that will be used throughout the manuscript. They include the lower bound of the loss operator and the upper bound on the gain operator corresponding to the parts $b_{1}^{\varepsilon}$ and $b_{2}^{\varepsilon}$ of the angular kernel. We state a
result on the $L^{\infty}$-norm propagation for solutions which based on these two estimates and the classical $L^{2}$-norm propagation.

Section 3 concerns the propagation and generation of exponentially weighted $L^{p}$ norms of the solution to the homogeneous Boltzmann equation. The case of hard potentials and the case of Maxwell molecules are studied separately. The latter one requires the a priori boundedness of the entropy. We remark that the generation results holds only for hard potentials.

In Section 4, we prove exponentially-tailed Sobolev regularity propagation for solutions of the homogeneous Boltzmann equation. Propagation of regularity has been discussed before in $[35,5]$. One of the central ingredients for the proof of propagation of Sobolev norms is the estimate [17, Theorem 2.1] which is valid under the assumption $b \in L^{2}\left(\mathbb{S}^{d-1}\right)$. This result was used in [35] to prove propagation of regularity in the case of hard potentials with polynomial weights and later, indirectly, in [5] for exponential weights. Three extensions are given in this section with respect to [35,5], (1) we relax the assumption on $b$ to merely $b \in L^{1}\left(\mathbb{S}^{d-1}\right),(2)$ we are able to prove propagation of fractional regularity by introducing pointwise/strong commutators, and (3) Maxwell molecules are considered, all in the context of exponential tails. Although our main goal is to prove all previous extensions in the context of exponential weights in the spirit of [5], similar results follow with the same line of reasoning for polynomial weights of any order.

Finally, in Section 5 we show the exponentially fast convergence towards thermodynamical equilibrium and prove, as a corollary, a decomposition theorem for propagation of smoothness and roughness in the case of hard potentials. The effort is concentrated in two fronts: (1) provide a proof in the context of integrable scattering kernel hypothesis assuming (2) general physical data, that is, initial data having only finite mass, energy, and entropy. These results generalize classical references in the topic such as [12, 33, 35, 39] at the level of the model and the initial data. An entropic method [38] together with the technique of spectral space enlargement [33, 29] will lead to the desired results. In contrast to the usual argument made in the proof of exponential convergence that uses a decomposition theorem first and then an entropy method, our argument eliminates the need of the decomposition theorem. This considerably reduces the technicalities here and in other contexts where entropic methods are used in Boltzmann-like equations.
1.2. Notation. We work with classical Lebesgue spaces $L^{p}\left(\mathbb{R}^{d}\right)$ for $p \in[1, \infty]$. The addition of polynomial or exponential weights are central throughout the manuscript. No particular notation will be used, however, in some places we adopt the following standard notation for convenience

for some $\mu \geq 0, r>0$, and $\alpha>0$. We restrict ourself to the Sobolev spaces $H^{k}\left(\mathbb{R}^{d}\right)$, with $k \geq 0$, defined as

Here, the operator $(1+(-\Delta))^{\frac{k}{2}}$ is defined using the Fourier transform $\mathcal{F}$,

where, we recall, the brackets stand for $\langle\xi\rangle:=\sqrt{1+|\xi|^{2}}$. Polynomial and exponential weights will also be used in these spaces,

for some positive $r$ and $\alpha$. These are the spaces of functions enjoying Sobolev regularity with polynomial and exponential tails respectively. Observe that weights were chosen to be outside the differentiation operator. Special care has to be made with this choice when fractional differentiation is performed in the particular case of exponential weights. Finally, we will commonly use the norm

for the intersection space $L^{p}\left(\mathbb{R}^{d}\right) \cap L^{q}\left(\mathbb{R}^{d}\right)$, with $p, q \in[1, \infty]$.

## 2. IMPORTANT LEMMAS AND $L^{\infty}$-PROPAGATION

We begin this section with a classical inequality used to obtain a lower estimate for the loss operator $Q^{-}$. This estimate is well know in the community when entropy is assumed to be finite, see for example [11], and it has been used in a central way in the analysis of moments [42] and the propagation of $L^{p}$-norms [35]. The case where no finite entropy is assumed is presented in [25], however, the proof is strongly based in the fact that $f(t, v)$ solves the Boltzmann equation. Refer to [4, Lemma 27] and [7, Lemma 4.2] for an elementary proof based only on functional arguments.

Lemma 2.1 (Lower bound). Fix $\gamma \in[0,2]$, and assume $0 \leq\{f(t)\}_{t \geq 0} \subset L_{2}^{1}\left(\mathbb{R}^{d}\right)$ satisfies

for some positive constants $C$ and $c$. Assume also the boundedness of some $2^{+}$moment

Remark 2.1. The symbol $a^{ \pm}$, with $a>0$, denotes a fixed real number bigger ( + ) or smaller (-) than a.

Lemma 2.2 (Upper bound). Write $b=b_{1}^{\varepsilon}+b_{2}^{\varepsilon}$ as in (3). Then, for every $\gamma \geq 0$,

The constants are such that $C(b) \sim\|b\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}$ and $\mathfrak{m}\left(b_{2}^{\epsilon}\right) \sim\left\|b_{2}^{\varepsilon}\right\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}$. In particular, $\lim _{\varepsilon \rightarrow 0} \mathfrak{m}\left(b_{2}^{\epsilon}\right)=0$.

Proof. Both estimates are a direct consequence of Young's inequality for the gain part of the collision operator [3, Theorem 1] (see Theorem 6.1 in the appendix for a clear statement of such theorem). Indeed, recalling that $b$ has support in $[0,1]$, we use for the first estimate in (6) the case $(p, q, r)=(2,2, \infty)$ with constant (85)

For the inequality we used the fact that $(1-s)^{-1} \leq 2 \varepsilon^{-2}$ in the support of $b_{1}^{\varepsilon} \leq b$. For the second estimate we use the case the case $(p, q, r)=(\infty, 1, \infty)$ with constant (86)

The fact that $\lim _{\varepsilon \rightarrow 0} \mathfrak{m}\left(b_{2}^{\epsilon}\right)=0$ is a direct consequence of the monotone convergence theorem.

Remark 2.2. In the sequel the symbol $\mathfrak{m}(b)$ will be interpreted, more generally, as a quantity proportional to $\|b\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}$ having a constant of proportionality that depends only on the dimension $d \geq 2$ and $\gamma \geq 0$. Such symbol will be reserved to a quantity that will be taken sufficiently small at some point in the argument in question.

A direct application of these two lemmas gives an elementary proof of the $L^{\infty}$-norm propagation for the homogeneous Boltzmann equation, see [4, Theorem 31].
Theorem 2.1 (Propagation of $\left.L^{\infty}\right)$. Take $\gamma \in(0,1], b \in L^{1}\left(\mathbb{S}^{d-1}\right)$ be the angular kernel (with mass normalized to unity) and

$$
\left\|f_{0}\right\|_{\left(L_{2+}^{1} \cap L^{\infty}\right)\left(\mathbb{R}^{d}\right)}=C_{o},
$$

for some positive constant $C_{o}$. Then, there exist constant $C\left(f_{0}\right)>0$ depending on $C_{o}, \gamma$ and $b$ such that

$$
\|f(t, \cdot)\|_{L^{\infty}\left(\mathbb{R}^{d}\right)} \leq C\left(f_{0}\right), \quad t \geq 0
$$

for the solution $f(t, v)$ of the Boltzmann equation.

## 3. Propagation and generation of $L^{p}$-EXPonential tail integrability for CUT-OFF Boltzmann

In this section we study the propagation and generation of $L^{p}$-exponential tails. The argument for the case $p \in[1, \infty)$ follows closely the standard theory used in the literature for polynomial weights. The reasoning for the case $p=\infty$ is novel and follows the one given in previous section. We divide the proof in the hard potentials $\gamma \in(0,2]$ and Maxwell molecules $\gamma=0$ cases as they are slightly different. For instance, as opposed to the hard potentials model, the Maxwell molecules model does not create tail only propagates it.

### 3.1. Hard potential case.

Theorem 3.1 (Propagation of $L^{p}$-exponential tails). Let $\gamma \in(0,2]$ be the potential exponent, $b \in L^{1}\left(\mathbb{S}^{d-1}\right)$ be the angular kernel (with mass normalized to unity), and

$$
\left\|f_{0}(\cdot) e^{a_{o}\langle\cdot\rangle^{\alpha}}\right\|_{\left(L^{1} \cap L^{p}\right)\left(\mathbb{R}^{d}\right)}=C_{o}<\infty
$$

for some $\alpha \in(0,2], p \in[1, \infty]$ and positive constants $a_{o}$ and $C_{o}$. Then, there exist positive constants $a$ and $C$ depending on the initial mass, energy, $a_{o}, C_{o}, \gamma$ and $b$ such that

$$
\left\|f(t, \cdot) e^{a(\cdot \cdot)^{\alpha}}\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq C, \quad t \geq 0
$$

for the solution $f(t, v)$ of the Boltzmann equation.
Proof. One first notices that thanks to the propagation of moments of [2, Theorem 2]

$$
\begin{equation*}
\left\|f(t, \cdot) e^{\tilde{a} \cdot \cdot\rangle^{\alpha}}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)} \leq C, \quad t \geq 0 \tag{7}
\end{equation*}
$$

for some positive $\tilde{a}$ and $C$ with dependence as stated. Next, note that for any $\alpha \in[0,2]$

$$
\begin{aligned}
\langle v\rangle^{\alpha}=\left(1+|v|^{2}\right)^{\frac{\alpha}{2}} & \leq\left(1+|v|^{2}+\left|v_{*}\right|^{2}\right)^{\frac{\alpha}{2}}=\left(1+\left|v^{\prime}\right|^{2}+\left|v_{*}^{\prime}\right|^{2}\right)^{\frac{\alpha}{2}} \\
& \leq\left(1+\left|v^{\prime}\right|^{2}\right)^{\frac{\alpha}{2}}+\left|v_{*}^{\prime}\right|^{\alpha} \leq\left\langle v^{\prime}\right\rangle^{\alpha}+\left\langle\left. v_{*}^{\prime}\right|^{\alpha},\right.
\end{aligned}
$$

and therefore, $e^{r\langle v\rangle^{\alpha}} \leq e^{r\left\langle v^{\prime}\right\rangle^{\alpha}} e^{r\left\langle v_{*}^{\prime}\right\rangle^{\alpha}}$ for any $r>0$. As a consequence

$$
\begin{aligned}
Q(f, f)(v) e^{r\langle v\rangle^{\alpha}} & =Q^{+}(f, f)(v) e^{r\langle v\rangle^{\alpha}}-Q^{-}(f, f)(v) e^{r\left\langle\langle v\rangle^{\alpha}\right.} \\
& \leq Q^{+}\left(f e^{r\langle\cdot\rangle^{\alpha}}, f e^{r\langle\cdot\rangle^{\alpha}}\right)(v)-f(v) e^{r\langle v\rangle^{\alpha}}\left(f *|\cdot|^{\gamma}\right)(v)
\end{aligned}
$$

Thus, defining $g:=f e^{r(\langle \rangle\rangle^{\alpha}}$, the Boltzmann equation implies that

$$
\begin{equation*}
\partial_{t} g(v) \leq Q^{+}(g, g)(v)-g(v)\left(f *|\cdot|^{\gamma}\right)(v) . \tag{8}
\end{equation*}
$$

As a consequence of Lemma 2.1, estimate (8) implies that

$$
\begin{equation*}
\partial_{t} g(v) \leq Q^{+}(g, g)(v)-c_{o} g(v)\langle v\rangle^{\gamma} . \tag{9}
\end{equation*}
$$

Estimate (9) suffices to conclude using the techniques of [35, Theorem 4.1] or [6, Corollary 1.1] that

$$
\begin{equation*}
\sup _{t \geq 0}\|g(t, \cdot)\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq C_{p}\left(g_{0}\right), \quad \text { with } p \in(1, \infty) \tag{10}
\end{equation*}
$$

where $C_{p}\left(g_{0}\right)$ depends on an upper bound of $\left\|g_{0}\right\|_{L^{p}}+\sup _{t \geq 0}\|g(t, \cdot)\|_{L_{2}^{1}}$. Of course, such upper bound is finite for any $r<\min \left\{\tilde{a}, a_{o}\right\}$ thanks to (7) and the weighted $L^{p}$ integrability of $f_{0}$. So, setting $a<\min \left\{\tilde{a}, a_{o}\right\}$ proves the result for any $p \in(1, \infty)$.

Let us prove the case $p=\infty$. Observe that $|u| \leq \sqrt{2}\left|u^{+}\right| \leq \sqrt{2}\left\langle v_{*}^{\prime}\right\rangle\langle v\rangle$ by symmetrization of $b$. Then,

$$
Q^{+}(f, f)(v) \leq 2^{\frac{\gamma}{2}} Q_{o, b}^{+}\left(f, f\langle\cdot\rangle^{\gamma}\right)(v)\langle v\rangle^{\gamma} .
$$

Using estimate (9), we conclude that

$$
\begin{equation*}
\partial_{t} g(v) \leq\left(2^{\frac{\gamma}{2}} Q_{o, b}^{+}\left(g, g\langle\cdot\rangle^{\gamma}\right)(v)-c_{o} g(v)\right)\langle v\rangle^{\gamma} \tag{11}
\end{equation*}
$$

Furthermore, Lemma 2.2 leads to

$$
\begin{align*}
& \left\|Q_{o, b_{1}^{\varepsilon}}^{+}\left(g, g\langle\cdot\rangle^{\gamma}\right)\right\|_{L^{\infty}\left(\mathbb{R}^{d}\right)} \leq \varepsilon^{-\frac{d}{2}} C(b)\|g\|_{L^{2}\left(\mathbb{R}^{d}\right)}\left\|g\langle\cdot\rangle^{\gamma}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)},  \tag{12}\\
& \left\|Q_{o, b_{2}^{\varepsilon}}^{+}\left(g, g\langle\cdot\rangle^{\gamma}\right)\right\|_{L^{\infty}\left(\mathbb{R}^{d}\right)} \leq \mathfrak{m}\left(b_{2}^{\epsilon}\right)\|g\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}\left\|g\langle\cdot\rangle^{\gamma}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)} .
\end{align*}
$$

In addition, estimates (7) and (10) ensure that

$$
\begin{equation*}
\sup _{t \geq 0}\left(\left\|g(t)\langle\cdot\rangle^{\gamma}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}+\left\|g(t)\langle\cdot\rangle^{\gamma}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}\right) \leq C\left(g_{0}\right), \quad \text { for any } r<\min \left\{\tilde{a}, a_{o}\right\} \tag{13}
\end{equation*}
$$

Using again the splitting (3) as $Q_{o, b}^{+}=Q_{o, b_{1}^{\varepsilon}}^{+}+Q_{o, b_{2}^{\varepsilon}}^{+}$, the conclusion from the estimates (11), (12) and (13) is that for some constants $C_{i}\left(g_{0}, b\right), i=1,2$, depending on $g_{0}$ through the norm $\left\|g_{0}\right\|_{L^{1} \cap L^{2}\left(\mathbb{R}^{d}\right)}$ it holds that

$$
\begin{align*}
\partial_{t} g(t, v) & \leq\left(\varepsilon^{-\frac{d}{2}} C_{1}\left(g_{0}\right)+\mathfrak{m}\left(b_{2}^{\epsilon}\right) C_{2}\left(g_{0}\right)\|g(t)\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}\right)\langle v\rangle^{\gamma}-c_{o} g(t, v)\langle v\rangle^{\gamma} \\
& =\left(\tilde{C}_{1}\left(g_{0}\right)+\frac{c_{o}}{4}\|g(t)\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}\right)\langle v\rangle^{\gamma}-c_{o} g(t, v)\langle v\rangle^{\gamma} \tag{14}
\end{align*}
$$

where, for the latter, we simply took $\varepsilon>0$ sufficiently small such that $\mathfrak{m}\left(b_{2}^{\epsilon}\right) C_{2}\left(g_{0}\right) \leq \frac{c_{o}}{4}$. Finally, let us integrate estimate (14) to conclude that

$$
\begin{equation*}
\sup _{t \geq 0}\|g(t)\|_{L^{\infty}\left(\mathbb{R}^{d}\right)} \leq \frac{4}{3}\left(\left\|g_{0}\right\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}+\frac{\tilde{C}_{1}\left(g_{0}\right)}{c_{o}}\right)=: G\left(g_{0}\right) . \tag{15}
\end{equation*}
$$

Indeed, bear in mind that $\partial_{t} g$ exist a.e. in $\mathbb{R}^{+} \times \mathbb{R}^{d}$ since $f$ is solution of the Boltzmann equation. Thus, we can integrate estimate (14) in $[0, t]$ to obtain

$$
\begin{aligned}
g(t, v) & \leq g_{0}(v) e^{-c_{o}\langle v)^{\gamma} t}+\int_{0}^{t} e^{-c_{o}\langle v\rangle^{\gamma}(t-s)}\left(\tilde{C}_{1}\left(g_{0}\right)+\frac{c_{o}}{4}\|g\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}\right)\langle v\rangle^{\gamma} \mathrm{d} s \\
\leq & \left\|g_{0}\right\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}+\left(\tilde{C}_{1}\left(g_{0}\right)+\frac{c_{o}}{4} \sup _{0 \leq s \leq t}\|g(s)\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}\right)\langle v\rangle^{\gamma} \int_{0}^{t} e^{-c_{o}\left\langle v \gamma^{\gamma}(t-s)\right.} \mathrm{d} s \\
& \leq \frac{3}{4} G\left(g_{0}\right)+\frac{1}{4} \sup _{0 \leq s \leq t}\|g(s)\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}, \quad \text { a.e. in } v \in \mathbb{R}^{d} .
\end{aligned}
$$

As a consequence, for any $0 \leq t \leq T$ it holds

$$
\begin{equation*}
g(t, v) \leq \frac{3}{4} G\left(g_{0}\right)+\frac{1}{4} \sup _{0 \leq s \leq T}\|g(s)\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}, \quad \text { a.e. in } v \in \mathbb{R}^{d} . \tag{16}
\end{equation*}
$$

Estimate (15) readily follows after computing the essential supremum in $v \in \mathbb{R}^{d}$ and, then, the supremum in $t \in[0, T]$ in estimate (16). So, setting $a<\min \left\{\tilde{a}, a_{o}\right\}$ proves the result for $p=\infty$.

It is well know that instantaneous generation of tails at the level of moments occurs for the Boltzmann equation for hard potentials. This is at odds with the Maxwell molecules model where only propagation of tails is possible. This was first noticed in [42]. More recently, $L^{1}$-exponential tail generation has been studied in [2]. We show here that from $L^{1}$ exponential tail generation, it is possible to deduce $L^{p}$-exponential tail generation following the argument presented previously for propagation of exponential integrability. We should stress that integrability is not created only the tails are.

Theorem 3.2 (Generation of $L^{p}$-tails). Let $\gamma \in(0,2)$ be the potential exponent, $b \in$ $L^{1}\left(\mathbb{S}^{d-1}\right)$ be the angular kernel (with mass normalized to unity), and assume that for some $p \in(1, \infty)$

$$
\left\|f_{0}(\cdot)\right\|_{\left(L_{2}^{1} \cap L^{p}\right)\left(\mathbb{R}^{d}\right)}=C_{o}<\infty,
$$

for some constant $C_{o}>0$. Then, there exist positive constants a and $C$ depending on the initial mass, energy, $C_{o}, \gamma$ and $b$ such that

$$
\begin{equation*}
\left\|f(t, \cdot) e^{a \min \{1, t\}(\cdot)^{\gamma}}\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq C, \quad t \geq 0 \tag{17}
\end{equation*}
$$

for the solution $f(t, v)$ of the Boltzmann equation. This estimate is also true in the case $\gamma=2$ if a moment $2^{+}$is assumed to be finite for $f_{0}$.

For the case $p=+\infty$, with $\gamma \in(0,2)$, assume

$$
\left\|f_{0}(\cdot)\right\|_{\left(L_{2}^{1} \cap L_{2}^{2} \cap L^{\infty}\right)\left(\mathbb{R}^{d}\right)}=C_{o}<\infty .
$$

Then, estimate (17) holds true. Again, this estimate holds for $\gamma=2$ provided the $L_{2^{+}}^{1} \cap L_{2^{+}}^{2}$ norm is assumed finite for the initial datum.

Proof. Let us handle first the case $p \in(1, \infty)$. Note that for any $r>0$ and $\gamma \in(0,2]$ it follows that

$$
e^{r \min \{1, t\}\langle v\rangle^{\gamma}} \partial_{t} f(t, v)=\partial_{t} g(t, v)-r \chi_{[0,1)}(t)\langle v\rangle^{\gamma} g(t, v), \quad t \geq 0,
$$

where $g(t, v):=f(t, v) e^{r \min \left\{1, t t\langle v\rangle^{\gamma}\right.}$. Thus, arguing as in the proof of Theorem 3.1, it follows that

\partial_{t} g(v) \leq Q^{+}(g, g)(v)-\left(c_{o}-r\right) g(v)\langle v\rangle^{\gamma} .
$$

Moreover, in [2, Theorem 1] it is proved that if $f_{0} \in L_{2}^{1}\left(\mathbb{R}^{d}\right)$ then

$$
\left\|f(t, \cdot) e^{a_{o} \min \{1, t\}\left\langle\cdot \gamma^{\gamma}\right.}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)} \leq C_{o}, \quad t \geq 0
$$

for some positive constants $a_{o}$ and $C_{o}$ depending on the initial mass, energy, $\gamma$ and $b$. Choosing $r<\min \left\{a_{o}, c_{o}\right\}$ sufficiently small, this estimate suffices to conclude, using the techniques of [35, Theorem 4.1] or [6, Corollary 1.1], that

$$
\begin{equation*}
\sup _{t \geq 0}\|g(t, \cdot)\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq C_{p}\left(g_{0}\right), \quad \text { with } \gamma \in(0,2] \tag{18}
\end{equation*}
$$

where $C_{p}\left(g_{0}\right)$ depends on an upper bound of $\left\|g_{0}\right\|_{L^{p}}+\sup _{t \geq 0}\|g(t, \cdot)\|_{L_{\gamma^{+}}^{1}}<+\infty$. This concludes case $p \in(0, \infty)$ by choosing $a<\min \left\{a_{o}, c_{o}\right\}$ sufficiently small.

The case $p=\infty$ is obtained following the respective argument of Theorem 3.1 for this case. Indeed, one easily arrives to the estimate

$$
\partial_{t} g(v) \leq\left(2^{\frac{\gamma}{2}} Q_{o}^{+}\left(g, g\langle\cdot\rangle^{\gamma}\right)(v)-\left(c_{o}-r\right) g(v)\right)\langle v\rangle^{\gamma}
$$

We will choose $r=a$ with $a<c_{o}$ sufficiently small, thus, we only need to guarantee the finiteness of the term

$$
\sup _{t \geq 0}\left(\left\|g(t)\langle\cdot\rangle^{\gamma}\right\|_{L^{1}}+\left\|g(t)\langle\cdot\rangle^{\gamma}\right\|_{L^{2}}\right)
$$

This holds for any $\gamma \in(0,2)$ (recall that $f_{0} \in L_{2}^{1} \cap L_{2}^{2}$ ) due to the propagation of polynomial integrability [35, Theorem 4.1] and generation of exponential integrability Theorem 3.2 for the case $p=2$. The case $\gamma=2$ holds true by assuming $f_{0} \in L_{2^{+}}^{1} \cap L_{2^{+}}^{2}$ and invoking the same theorems.
3.2. Maxwell molecules case. Maxwell molecules, $\gamma=0$, is a critical case for uniform propagation of $L^{p}$ integrability for general initial data. Indeed, as soon as $\gamma<0$, i.e. soft potential case, the uniform propagation of moments is lost for general initial data, refer to [20] for an interesting discussion. In order to compensate for this issue, we will use propagation of entropy. Thus, we implicitly have the additional requirement on the initial data

$$
\int_{\mathbb{R}^{d}} f_{0}(v) \ln \left(f_{0}(v)\right) \mathrm{d} v<\infty
$$

that is, we work with initial data having finite initial entropy. Clearly, this is harmless since more restrictive conditions on $f_{0}$ are imposed in our context, namely, $f_{0} \in\left(L_{2}^{1} \cap L^{p}\right)\left(\mathbb{R}^{d}\right)$, for $p>1$. As a consequence, initial finite entropy is finite since for any $1<p<\frac{d}{d-1} \leq 2$

$$
\begin{aligned}
& \left|\int_{\mathbb{R}^{d}} f_{0}(v) \ln \left(f_{0}(v)\right) \mathrm{d} v\right| \leq \int_{\left\{f_{0} \leq 1\right\}}\left|f_{0}(v) \ln \left(f_{0}(v)\right)\right| \mathrm{d} v+\int_{\left\{f_{0} \geq 1\right\}}\left|f_{0}(v) \ln \left(f_{0}(v)\right)\right| \mathrm{d} v \\
& \quad \leq C_{p} \int_{\left\{f_{0} \leq 1\right\}}\left|f_{0}(v)\right|^{\frac{1}{p}} \mathrm{~d} v+\int_{\left\{f_{0} \geq 1\right\}}\left|f_{0}(v)\right|^{p} \mathrm{~d} v \\
& \quad \leq C_{p, d}\left(\int_{\left\{f_{0} \leq 1\right\}} f_{0}(v)\langle v\rangle^{p} \mathrm{~d} v\right)^{\frac{1}{p}}+\int_{\left\{f_{0} \geq 1\right\}}\left|f_{0}(v)\right|^{p} \mathrm{~d} v=: C\left(d,\left\|f_{0}\right\|_{\left(L_{2}^{1} \cap L^{p}\right)\left(\mathbb{R}^{d}\right)}\right)<+\infty .
\end{aligned}
$$

In the second estimate we used that $|x \ln (x)| \leq C_{p} x^{\frac{1}{p}}$, for any $p>1$ and $x \in[0,1]$. Furthermore, it is well known that using energy conservation and entropy dissipation it
follows for $f(t, v)$, the solution of the homogeneous Boltzmann equation (see [24, page 329] or more recently [9, Lemma A.1]), that

$$
\begin{equation*}
\sup _{t \geq 0} \int_{\mathbb{R}^{d}} f(t, v)|\ln (f(t, v))| \mathrm{d} v \leq C\left(\int f_{0} \ln \left(f_{0}\right), \int f_{0}|\cdot|^{2}\right) . \tag{19}
\end{equation*}
$$

Lemma 3.1. For any $K>1, \varepsilon>0$ and $p \in[1, \infty]$ one has

$$
\begin{aligned}
& \left\|Q_{o, b}^{+}(f, f)\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq \frac{C(b)}{\ln (K)}\|f \ln (f)\|_{L^{1}\left(\mathbb{R}^{d}\right)}\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)} \\
& \quad+\varepsilon^{-\frac{d}{2 p^{\prime}}} K^{\frac{1}{2^{\prime}}} C(b)\|f\|_{L^{1}\left(\mathbb{R}^{d}\right)}^{1+\frac{1}{2 p}}\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{\frac{1}{2}}+\mathfrak{m}\left(b_{2}^{\epsilon}\right)\|f\|_{L^{1}\left(\mathbb{R}^{d}\right)}\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)} .
\end{aligned}
$$

Proof. Use the usual decomposition (3) to write $Q_{o, b}^{+}(f, f)=Q_{o, b 1}^{+}(f, f)+Q_{o, b_{2}^{\varepsilon}}^{+}(f, f)$. On the one hand, from [3, Theorem 1] or Theorem 6.1 we know that

\left\|Q_{o, b_{2}^{\varepsilon}}^{+}(f, f)\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq \mathfrak{m}\left(b_{2}^{\epsilon}\right)\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}\|f\|_{L^{1}\left(\mathbb{R}^{d}\right)}
$$

On the other hand, note that bilinearity implies

\begin{aligned}
Q_{o, b_{1}^{\varepsilon}}^{+}(f, f) & =Q_{o, b 1}^{+}\left(f, f 1_{\{f \leq K\}}\right)+Q_{o, b_{1}^{\varepsilon}}^{+}\left(f, f 1_{\{f>K\}}\right) \\
& \leq Q_{o, b_{1}^{b}}^{+}\left(f, f 1_{\{f \leq K\}}\right)+\ln (K)^{-1} Q_{o, b_{1}^{\prime}}^{+}(f, f \ln (f)) .
\end{aligned}
$$

Moreover, Young's inequality for the gain collision operator, see [3, Theorem 1] or Theorem 6.1, implies

\begin{aligned}
\left\|Q_{o, b_{1}^{\varepsilon}}^{+}(f, f \ln (f))\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} & \leq C(b)\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}\|f \ln (f)\|_{L^{1}\left(\mathbb{R}^{d}\right)}, \\
\left\|Q_{o, b \overline{1}}^{+}\left(f, f 1_{\{f \leq K\}}\right)\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} & \leq \varepsilon^{-\frac{d}{2 p^{\prime}}} C(b)\|f\|_{L^{\frac{2 p}{p+1}}\left(\mathbb{R}^{d}\right)}\left\|f 1_{\{f \leq K\}}\right\|_{L^{\frac{2 p}{p+1}}\left(\mathbb{R}^{d}\right)} \\
& \leq \varepsilon^{-\frac{d}{2 p^{\prime}}} K^{\frac{1}{2 p^{\prime}}} C(b)\|f\|_{L^{\frac{2 p}{p+1}}\left(\mathbb{R}^{d}\right)}\|f\|_{L^{\frac{p}{2 p}}\left(\mathbb{R}^{d}\right)} .
\end{aligned}
$$

The estimate follows using, in the last inequality, the interpolation

$$
\begin{equation*}
\|f\|_{L^{\frac{2 p}{p+1}}\left(\mathbb{R}^{d}\right)} \leq\|f\|_{L^{1}\left(\mathbb{R}^{d}\right)}^{\frac{1}{2}}\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{\frac{1}{2}} \tag{20}
\end{equation*}
$$

Proposition 3.1. Consider Maxwell molecules $\gamma=0$ with angular kernel $b \in L^{1}\left(\mathbb{S}^{d-1}\right)$ (with mass normalized to unity). Assume that the initial data satisfies

$$
\left\|f_{0}(\cdot)\right\|_{\left(L_{2}^{1} \cap L^{p}\right)\left(\mathbb{R}^{d}\right)}<\infty,
$$

for some $p \in[1, \infty]$. Then, there exist positive constant $C$ depending on the initial mass, energy, entropy, $\left\|f_{0}\right\|_{L^{p}\left(\mathbb{R}^{d}\right)}, \gamma$ and $b$ such that

$$
\|f(t, \cdot)\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq C, \quad t \geq 0,
$$

for the solution $f(t, v)$ of the Boltzmann equation.

Proof. Without loss of generality assume $\|f(t, \cdot)\|_{L^{1}\left(\mathbb{R}^{d}\right)}=1$. The case $p \in[1, \infty)$ is a direct consequence of Lemma 3.1. Indeed, multiply the Boltzmann equation by $f^{p-1}$ and integrate in velocity to obtain

$$
\begin{aligned}
& \frac{1}{p} \frac{\mathrm{~d}}{\mathrm{~d} t}\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{p}=\int_{\mathbb{R}^{d}} Q^{+}(f, f)(v) f^{p-1}(v) \mathrm{d} v-\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{p} \\
& \leq\left\|Q^{+}(f, f)\right\|_{L^{p}\left(\mathbb{R}^{d}\right)}\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{p-1}-\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{p}
\end{aligned}
$$

Taking $K>1$ sufficiently large and $\varepsilon>0$ sufficiently small in Lemma 3.1, we simply obtain that

$$
\frac{1}{p} \frac{\mathrm{~d}}{\mathrm{~d} t}\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{p} \leq C\left(f_{0}\right)\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{p-\frac{1}{2}}-\frac{1}{2}\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{p},
$$

where the cumulative constant $C\left(f_{0}\right)$ depends on mass, energy, entropy and scattering kernel $b$. This is enough to conclude that

$$
\begin{equation*}
\sup _{t \geq 0}\|f(t)\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq \max \left\{\left\|f_{0}\right\|_{L^{p}\left(\mathbb{R}^{d}\right)}, 4 C\left(f_{0}\right)^{2}\right\} . \tag{21}
\end{equation*}
$$

The case $p=\infty$ is straightforward from here. Indeed, using (12) which is valid for $\gamma=0$, it follows that

$$
\begin{aligned}
\partial_{t} f(v) & \leq \varepsilon^{-\frac{d}{2}} C(b)\|f\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2}+\mathfrak{m}\left(b_{2}^{\epsilon}\right)\|f\|_{L^{1}\left(\mathbb{R}^{d}\right)}\|f\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}-f(v) \\
& \leq C\left(f_{0}\right)+\frac{1}{4}\|f\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}-f(v) .
\end{aligned}
$$

We argue as in Theorem 3.1 to conclude that

$$
\sup _{t \geq 0}\|f(t)\|_{L^{\infty}\left(\mathbb{R}^{d}\right)} \leq \frac{4}{3}\left(\left\|f_{0}\right\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}+C\left(f_{0}\right)\right) .
$$

Remark 3.1. Since Lemma 3.1 is valid for $p=\infty$, estimate (21) does not degenerate as $p \rightarrow \infty$. Thus, the $L^{\infty}$-estimate can be obtained by simply sending $p \rightarrow \infty$ in (21). This is at odds with the usual estimates for hard potentials which use interpolation and degenerate as $p$ increases to infinity. Of course, the reason for this difference is that Lemma 3.1 explicitly uses the propagation of entropy which was avoided in the context of hard potentials. This approach using the entropy leads to an alternative argument for propagation of $L^{p}$-norms for hard potentials as long as propagation of entropic moments is at hand. Such propagation of entropic moments in fact happens as we prove later in the last section.

Lemma 3.2. Define $g:=f e^{r\langle\cdot\rangle^{\alpha}}$, and set $a>0, r \in(0, a), \alpha \in(0,2]$. Then, for any $R>0, \varepsilon>0$ and $p \in[1, \infty]$ it holds that

$$
\begin{aligned}
& \left\|Q^{+}(g, g)\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq e^{-(a-r) R^{\alpha}} C(b)\left\|f e^{a \cdot \cdot\rangle^{\alpha}}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}\|g\|_{L^{p}\left(\mathbb{R}^{d}\right)} \\
& \quad+e^{r R^{\alpha}} \varepsilon^{-\frac{d}{2 p^{\prime}}} C(b) \sqrt{\|f\|_{1}\|f\|_{p}\|g\|_{1}\|g\|_{p}}+\mathfrak{m}\left(b_{2}^{\epsilon}\right)\|g\|_{L^{1}\left(\mathbb{R}^{d}\right)}\|g\|_{L^{p}\left(\mathbb{R}^{d}\right)} .
\end{aligned}
$$

Proof. Note that for any $R>0$ we can write

$$
Q^{+}(g, g)=Q^{+}\left(g, g 1_{|\cdot| \leq R}\right)+Q^{+}\left(g, g 1_{|\cdot|>R}\right) .
$$

On the one hand, for the latter one simply estimates

$$
\begin{aligned}
\left\|Q^{+}\left(g, g 1_{|\cdot|>R}\right)\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} & \leq C(b)\|g\|_{L^{p}\left(\mathbb{R}^{d}\right)}\left\|g 1_{|\cdot|>R}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)} \\
& \leq e^{-(a-r) R^{\alpha}} C(b)\|g\|_{L^{p}\left(\mathbb{R}^{d}\right)}\left\|f e^{a \cdot \cdot\rangle^{\alpha}}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)} .
\end{aligned}
$$

On the other hand, for the former one uses the decomposition (3)

$$
Q^{+}\left(g, g 1_{|\cdot| \leq R}\right)=Q_{b_{\varepsilon}^{1}}^{+}\left(g, g 1_{|\cdot| \leq R}\right)+Q_{b_{\varepsilon}^{2}}^{+}\left(g, g 1_{|\cdot| \leq R}\right) .
$$

Each of the terms on the right side is easily controlled by the Young's inequality for the gain collision operator. Indeed, for the operator with $b_{\varepsilon}^{1}$

$$
\begin{aligned}
\left\|Q_{b_{\varepsilon}^{1}}^{+}\left(g, g 1_{|\cdot| \leq R}\right)\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} & \leq \varepsilon^{-\frac{d}{2 p^{\prime}}} C(b)\|g\|_{L^{\frac{2 p}{p+1}}\left(\mathbb{R}^{d}\right)}\left\|g 1_{|\cdot| \leq R}\right\|_{L^{\frac{2 p}{p+1}}\left(\mathbb{R}^{d}\right)} \\
& \leq e^{r R^{\alpha}} \varepsilon^{-\frac{d}{2 p^{\prime}}} C(b)\|g\|_{L^{\frac{2 p}{p+1}}}\left(\mathbb{R}^{d}\right)
\end{aligned}\|f\|_{L^{\frac{2 p}{p+1}}\left(\mathbb{R}^{d}\right)}
$$

where the last inequality follows from (20). Similarly, for the operator with $b_{\varepsilon}^{2}$

$$
\left\|Q_{b_{\varepsilon}^{2}}^{+}\left(g, g 1_{|\cdot| \leq R}\right)\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq \mathfrak{m}\left(b_{2}^{\epsilon}\right)\|g\|_{L^{p}\left(\mathbb{R}^{d}\right)}\left\|g 1_{|\cdot| \leq R}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)} \leq \mathfrak{m}\left(b_{2}^{\epsilon}\right)\|g\|_{L^{p}\left(\mathbb{R}^{d}\right)}\|g\|_{L^{1}\left(\mathbb{R}^{d}\right)} .
$$

The result follows after gathering these estimates.
Theorem 3.3. Consider Maxwell molecules $\gamma=0$, let $b \in L^{1}\left(\mathbb{S}^{d-1}\right)$ be the angular kernel (with mass normalized to unity) and suppose

$$
\left\|f_{0}(\cdot) e^{\left.a_{o}\langle\cdot\rangle\right\rangle^{\alpha}}\right\|_{\left(L^{1} \cap L^{p}\right)\left(\mathbb{R}^{d}\right)}=C_{o}<\infty
$$

for some $\alpha \in(0,2], p \in[1, \infty]$ and positive constants $a_{o}$ and $C_{o}$. Then, there exist positive constants $a$ and $C$ depending on the initial mass, energy, entropy, $a_{o}, C_{o}$ and $b$ such that

$$
\left\|f(t, \cdot) e^{a\langle\cdot \cdot\rangle^{\alpha}}\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq C, \quad t \geq 0,
$$

for the solution $f(t, v)$ of the Boltzmann equation.
Proof. Again, our first step consists in noticing the propagation of exponential moments for Maxwell molecules [36, Theorem 4.1]

$$
\begin{equation*}
\left\|f(t, \cdot) e^{\tilde{a} \cdot \cdot\rangle^{\alpha}}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)} \leq C, \quad t \geq 0 \tag{22}
\end{equation*}
$$

for some positive $\tilde{a}$ and $C$ with dependence as stated. Now, following the notation and argument of Theorem 3.1, we arrive to the equivalent of equation (9)

$$
\begin{equation*}
\partial_{t} g(v) \leq Q^{+}(g, g)(v)-g(v), \quad \text { recall that } g:=f e^{a<\cdot \cdot^{\alpha}} . \tag{23}
\end{equation*}
$$

After multiplying (23) by $g^{p-1}$ and integrating in velocity one concludes, as usual, that

$$
\begin{equation*}
\frac{1}{p} \frac{\mathrm{~d}}{\mathrm{~d} t}\|g\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq\left\|Q^{+}(g, g)\right\|_{L^{p}\left(\mathbb{R}^{d}\right)}\|g\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{p-1}-\|g\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{p} \tag{24}
\end{equation*}
$$

Furthermore, the norms $\left\|f e^{r \cdot \cdot\rangle^{\alpha}}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}$, with $r \in(0, a]$, are uniformly bounded by (22), and the norm $\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}$ is uniformly bounded by Proposition 3.1. As a consequence, using Lemma 3.2 for $R>0$ sufficiently large and $\varepsilon>0$ sufficiently small, we can find a cumulative constant depending only on $g_{0}$ such that

$$
\begin{equation*}
\left\|Q^{+}(g, g)\right\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq C\left(g_{0}\right)\|g\|_{L^{p}\left(\mathbb{R}^{d}\right)}^{\frac{1}{2}}+\frac{1}{2}\|g\|_{L^{p}\left(\mathbb{R}^{d}\right)} \tag{25}
\end{equation*}
$$

From (24) and (25) it readily follows that

$$
\begin{equation*}
\sup _{t \geq 0}\|g(t)\|_{L^{p}\left(\mathbb{R}^{d}\right)} \leq \max \left\{\left\|g_{0}\right\|_{L^{p}\left(\mathbb{R}^{d}\right)}, 4 C\left(g_{0}\right)^{2}\right\} \tag{26}
\end{equation*}
$$

Finally, the case $p=\infty$ goes in the same manner as in Theorem 3.1, or simply by taking $p \rightarrow \infty$ in (26).

## 4. Propagation of exponentially-tailed Sobolev regularity

In the sequel, the Fourier transform $\mathcal{F}$ is denoted by $\widehat{f}:=\mathcal{F}(f)$ for any tempered distribution $f$. We continue using the shorthand notation $\hat{\xi}:=\xi /|\xi|$, with $\xi \in \mathbb{R}^{d}$, to denote unitary vectors since it should not present any confusion with that of the Fourier transform. A central identity in the analysis is [17, equation (2.15)] which is a generalization of that of Bobylev for Maxwell molecules [13]; take any $\left(v, v_{*}\right)$-integrable function $F_{x}\left(v, v_{*}\right)$, with $x \in[-1,1]$, it holds that

$$
\begin{equation*}
\mathcal{F}\left\{\int_{\mathbb{R}^{d}} \int_{\mathbb{S}^{d-1}} F_{\hat{u} \cdot \sigma}\left(v^{\prime}, v_{*}^{\prime}\right) \mathrm{d} \sigma \mathrm{~d} v_{*}\right\}(\xi)=\int_{\mathbb{S}^{d-1}} \widehat{F_{\hat{\xi} \cdot \sigma}}\left(\xi^{+}, \xi^{-}\right) \mathrm{d} \sigma, \quad \xi^{ \pm}:=\frac{\xi \pm|\xi| \sigma}{2} \tag{27}
\end{equation*}
$$

In formula (27), $\widehat{F_{x}}$ is the Fourier transform of $F_{x}$ in the variables $\left(v, v_{*}\right)$ keeping $x \in[-1,1]$ fixed. Such formula is applied to $F_{\hat{u} \cdot \sigma}\left(v^{\prime}, v_{*}^{\prime}\right)=f\left(v^{\prime}\right) g\left(v_{*}^{\prime}\right) B(|u|, \hat{u} \cdot \sigma)$ in [17], however, in our context we will need its full generality. Let us give a short proof of identity (27) using the weak formulation

$$
\int_{\mathbb{R}^{d}}\left(\int_{\mathbb{R}^{d}} \int_{\mathbb{S}^{d-1}} F_{\hat{u} \cdot \sigma}\left(v^{\prime}, v_{*}^{\prime}\right) \mathrm{d} \sigma \mathrm{~d} v_{*}\right) e^{-i v \cdot \xi} \mathrm{~d} v=\int_{\mathbb{R}^{d}} \int_{\mathbb{R}^{d}} \int_{\mathbb{S}^{d-1}} F_{\hat{u} \cdot \sigma}\left(v, v_{*}\right) e^{-i v^{\prime} \cdot \xi} \mathrm{d} \sigma \mathrm{~d} v_{*} \mathrm{~d} v .
$$

Now, for any $\left(v, v_{*}, \xi\right)$ fixed, it follows that

$$
\begin{aligned}
& \int_{\mathbb{S}^{d-1}} F_{\hat{u} \cdot \sigma}\left(v, v_{*}\right) e^{-i v^{\prime} \cdot \xi} \mathrm{d} \sigma=\int_{\mathbb{S}^{d-1}} F_{\hat{u} \cdot \sigma}\left(v, v_{*}\right) e^{i u u^{-} \cdot \xi} \mathrm{d} \sigma e^{-i v \cdot \xi} \\
& =\int_{\mathbb{S}^{d-1}} F_{\hat{\xi} \cdot \sigma}\left(v, v_{*}\right) e^{i u \cdot \xi^{-}} \mathrm{d} \sigma e^{-i v \cdot \xi}=\int_{\mathbb{S}^{d-1}} F_{\hat{\xi} \cdot \sigma}\left(v, v_{*}\right) e^{-i v_{*} \cdot \xi^{-}} e^{-i v \cdot \xi^{+}} \mathrm{d} \sigma .
\end{aligned}
$$

We used in the second equality the change of variables $\sigma \rightarrow \mathrm{R} \sigma$ where R is the reflection that interchanges the unit vectors $\hat{u}$ and $\hat{\xi}$. As a consequence,

$$
\begin{aligned}
& \int_{\mathbb{R}^{d}}\left(\int_{\mathbb{R}^{d}} \int_{\mathbb{S}^{d-1}} F_{\hat{u} \cdot \sigma}\left(v^{\prime}, v_{*}^{\prime}\right) \mathrm{d} \sigma \mathrm{~d} v_{*}\right) e^{-i v \cdot \xi} \mathrm{~d} v \\
&=\int_{\mathbb{S}^{d-1}}\left(\int_{\mathbb{R}^{d}} \int_{\mathbb{R}^{d}} F_{\hat{\xi} \cdot \sigma}\left(v, v_{*}\right) e^{-i\left(v, v_{*}\right) \cdot\left(\xi^{+}, \xi^{-}\right)} \mathrm{d} v_{*} \mathrm{~d} v\right) \mathrm{d} \sigma
\end{aligned}
$$

which is the desired identity.
Let us mention, in addition, that the proofs in this section are explicitly written for propagation of Sobolev regularity with exponential weights. Similar results, shown with analogous arguments, hold for polynomial weights. Also, we will restrict ourselves only to the physical range $\gamma \in[0,1]$; this is not central in the argument, but it simplifies some statements. More important is the restriction $\alpha \in(0,1]$ in the exponential tail, central for the validity of some estimates with fractional commutators.
4.1. Commutators. We prove in this section that fractional differentiation commutes with the collision operator up to a lower order remainder. This result is typical of convolution like operators and happens for both, the gain and loss Boltzmann operators. These commutator estimates are new in the context of cut-off Boltzmann equation, however, the idea has been used before in the context of Boltzmann equation without cut-off to develop an $L^{2}\left(\mathbb{R}^{d}\right)$ regularity theory, see for example [1, Section 3]. The technique used to prove these estimates is usually pseudo-differential calculus; here we take a more elementary approach exploiting formula (27). This method is flexible and it could be adapted to study propagation in general $L^{p}\left(\mathbb{R}^{d}\right)$ spaces because our commutator identities hold in the pointwise sense. We do not explore this path and content ourselves with the presentation of the $L^{2}\left(\mathbb{R}^{2}\right)$ theory.

Lemma 4.1 (Commutator for the loss operator). Take any $\gamma \in[0,1], s \in(0,1], r \in\left[0, \frac{1}{2}\right)$ and $\alpha \in(0,1]$. Then,

$$
(1+(-\Delta))^{\frac{s}{2}} Q_{\gamma, b}^{-}(f, g)=Q_{\gamma, b}^{-}\left((1+(-\Delta))^{\frac{s}{2}} f, g\right)+\mathcal{I}^{-}(f, g)
$$

where

$$
\left\{\begin{array}{cl}
\mathcal{I}^{-}(f, g)=0 & \text { for } \gamma=0, \\
\left\|\mathcal{I}^{-}(f, g) e^{r(\cdot)\rangle^{\alpha}}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)} \leq C\|b\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}\left\|f e^{r(\cdot)^{\alpha}}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}\|g\|_{L_{\frac{d^{+}-(1-\gamma)}{2}}^{2}}\left(\mathbb{R}^{d}\right) & \text { for } \gamma \in(0,1],
\end{array}\right.
$$

with constant $C:=C(d, s, \gamma, r, \alpha)$.
Proof. The case $\gamma=0$ is trivial, thus, consider $\gamma \in(0,1]$. Using Lemma 6.3 one has

$$
(1+(-\Delta))^{\frac{s}{2}} Q_{\gamma, b}^{-}(f, g)(v)=Q_{\gamma, b}^{-}\left((1+(-\Delta))^{\frac{s}{2}} f, g\right)(v)+\int_{\mathbb{R}^{d}} g\left(v_{*}\right) \mathcal{R}_{v_{*}}(f)(v) \mathrm{d} v_{*} .
$$

Then, we define

$$
\begin{align*}
\mathcal{I}^{-}(f, g)(v) & :=\int_{\mathbb{R}^{d}} g\left(v_{*}\right) \mathcal{R}_{v_{*}}(f)(v) \mathrm{d} v_{*} \\
& =s \int_{\mathbb{R}^{d}} f(v-x) \nabla \varphi(x) \cdot \int_{\mathbb{R}^{d}} g\left(v_{*}\right)\left(\int_{0}^{1} \nabla|\cdot|^{\gamma}\left(v-v_{*}-\theta x\right) \mathrm{d} \theta\right) \mathrm{d} v_{*} \mathrm{~d} x . \tag{28}
\end{align*}
$$

Recall that $\varphi:=\mathcal{F}^{-1}\left\{\langle\cdot\rangle^{s-2}\right\}$ is the inverse Fourier transform of the Bessel kernel of order $2-s$. Now, let us first consider the case $s \in(0,1)$. Using Lemma 6.2 we control the integral
in $\theta$ in (28)

$$
\begin{aligned}
\left|\mathcal{I}^{-}(f, g)(v)\right| & \leq(2-\gamma) s \int_{\mathbb{R}^{d}}|f(v-x)||\nabla \varphi(x)|\left(\int_{\mathbb{R}^{d}}\left|g\left(v_{*}\right)\right|\left|v-v_{*}\right|^{-(1-\gamma)} \mathrm{d} v_{*}\right) \mathrm{d} x \\
& \leq s C_{d, \gamma}\|g\|_{L_{\frac{d^{+}-(1-\gamma)}{2}}^{2}\left(\mathbb{R}^{d}\right)} \int_{\mathbb{R}^{d}}|f(v-x)||\nabla \varphi(x)| \mathrm{d} x .
\end{aligned}
$$

In the last inequality we simply used Cauchy-Schwarz inequality in the $v_{*}$-integral,

$$
\begin{aligned}
\int_{\mathbb{R}^{d}} \frac{\left|g\left(v_{*}\right)\right|}{\left|v-v_{*}\right|^{1-\gamma}} \mathrm{d} v_{*} & \leq\left(\left.\int_{\mathbb{R}^{d}} g\left(v_{*}\right)\right|^{2}\left\langle v_{*}\right\rangle^{d^{+}-(1-\gamma)} \mathrm{d} v_{*}\right)^{\frac{1}{2}}\left(\int_{\mathbb{R}^{d}} \frac{\left\langle v_{*}\right\rangle^{-d^{+}+(1-\gamma)}}{\left|v-v_{*}\right|^{2(1-\gamma)}} \mathrm{d} v_{*}\right)^{\frac{1}{2}} \\
& \leq C_{d, \gamma}\|g\|_{L_{\frac{d^{+}-(1-\gamma)}{2}}^{2}}\left(\mathbb{R}^{d}\right)
\end{aligned}
$$

Additionally, $|v|^{\alpha} \leq|v-x|^{\alpha}+|x|^{\alpha}$ for any $\alpha \in(0,1]$. As a consequence,

$$
\begin{equation*}
\left|\mathcal{I}^{-}(f, g)(v)\right| e^{r\langle v\rangle^{\alpha}} \leq s C_{d, \gamma}\|g\|_{\frac{L^{d^{+}-(1-\gamma)}}{2}}\left(\mathbb{R}^{d}\right) \int_{\mathbb{R}^{d}}\left|f(v-x) e^{r\langle v-x\rangle^{\alpha}} \| \nabla \varphi(x) e^{r\langle x\rangle^{\alpha}}\right| \mathrm{d} x, \tag{29}
\end{equation*}
$$

and, invoking Young's inequality for convolutions yields

It is well known (see for instance [28, Proposition 6.1.5]) that $\varphi$ is smooth, except at the origin, and decaying as $e^{-\frac{|x|}{2}}$. Moreover,

We continue by using Lemma 6.3

The case $s=1$ needs special mention due to the fact that $\nabla \varphi$ is not integrable at the origin. However, this issue presents no obstacle for the estimate. Indeed, using Remark 6.1 in the Appendix, one has

& \quad+\left.C \int_{\mathbb{R}^{d}}| | x\right|^{\varepsilon} \nabla \varphi(x) \left\lvert\,\left(\int_{\mathbb{S}^{d-1}} \int_{\mathbb{R}^{d}} \int_{\mathbb{R}^{d}} \frac{\left|\tau_{x} f(v)\right|\left|\phi\left(v^{\prime}\right)\right|}{\left|v-v_{*}\right|^{1+\varepsilon-\gamma}}\left|g\left(v_{*}\right)\right| b(\hat{u} \cdot \sigma) \mathrm{d} v_{*} \mathrm{~d} v \mathrm{~d} \sigma\right) \mathrm{d} x .\right.

The first term on the right side can be estimated by adapting previous argument with $\nabla \varphi * f$ instead of $f$. While for the second term, one simply repeats the argument with $|\cdot|^{\varepsilon} \nabla \varphi$ instead of $\nabla \varphi$.

Controlling the term $\mathcal{I}_{1}^{+}$: Using the fact that

Remark 4.1. Although the method of proof of Lemmas 4.1 and 4.2 uses Fourier transform, the argument is essentially made in the velocity space. Thus, the method is flexible and it can be modified to obtain more general $L^{p}\left(\mathbb{R}^{d}\right)$ estimates. Observe also that polynomial weights can be readily handled using the same argument and leading to analogous estimates.
4.2. Regularization of the Boltzmann gain operator. The regularizing effect of the gain Boltzmann operator was first established in [31] and later, with a more elementary proof, polynomial weights were added in [41, 35]. The following theorem is a version of the regularizing effect using exponential weights, and the proof is a simple adaptation of the technique given in [10, Lemma 2.3] for polynomial weights.

Theorem 4.1. Assume that collision kernel is of the form

The constant in front of the inequality for the terms $n r$ and $r r$ is small due to the small mass of the remainder angular kernel $b_{r}$. For term $r n$ in the case of Maxwell molecules, i.e. $\gamma=0$, one can use a generalized version of the Young's inequality that includes the kinetic kernel potential, see [3, Corollary 8]

& \geq c_{0}\left\|e^{r\langle\cdot\rangle^{\alpha}}(1+(-\Delta))^{s / 2} f\right\|_{L_{\gamma / 2}^{2}\left(\mathbb{R}^{d}\right)}^{2}-C\left(f_{0}\right)\left\|e^{r(\cdot\rangle\rangle^{\alpha}}(1+(-\Delta))^{s / 2} f\right\|_{L^{2}\left(\mathbb{R}^{d}\right)} .
\end{align*}
$$

In summary, gathering estimates (44), (45), (46) and (47), it follows from (43) that

& \frac{\mathrm{d}}{\mathrm{~d} t}\left\|e^{r(\cdot \cdot)^{\alpha}}(1+(-\Delta))^{s / 2} f\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \\
& \quad \leq C\left(f_{0}, \varepsilon, \delta\right)+\left(\mathfrak{m}\left(b_{r}\right)+C(b, \varepsilon) \delta^{\frac{1}{2}}-c_{0}\right)\left\|e^{r(\cdot \cdot\rangle^{\alpha}}(1+(-\Delta))^{s / 2} f\right\|_{L_{\gamma / 2}^{2}\left(\mathbb{R}^{d}\right)}^{2} \\
& \quad \leq C\left(f_{0}, \varepsilon, \delta\right)-\frac{c_{0}}{2}\left\|e^{r(\zeta \cdot)^{\alpha}}(1+(-\Delta))^{s / 2} f\right\|_{L_{\gamma / 2}^{2}\left(\mathbb{R}^{d}\right)}^{2} .
\end{aligned}
$$

We used Young's inequality to control all the linear terms, for instance,

and consolidated all constants in $C\left(f_{0}, \varepsilon, \delta\right)$ and $C(b, \varepsilon)$. Additionally, for the last inequality we chose $\varepsilon$ and, then, $\delta:=\delta(\varepsilon)$ sufficiently small. This estimate proves the result.
Theorem 4.2 (Propagation of exponentially-tailed regularity). Assume $\gamma \in[0,1], k \geq 0$, and $\alpha \in(0,1]$. Also,

The constant depends as $C\left(f_{0}\right):=C\left(f_{0}, \gamma, k, r, \alpha\right)$ and lower order $H_{\text {exp }}^{k^{-}}\left(\mathbb{R}^{d}\right)$ Sobolev norms of $f_{0}$.
Proof. Here we only show the proof for $d \geq 3$. The same argument with slight modifications will do the job for the case $d=2$. The proof uses induction by first considering the case $k \in \mathbb{N}$. When $k=\{0,1\}$ the result follows using Theorem 3.1 or 3.3 for $k=0$, and Proposition 4.1 for $k=1$. For $k \geq 2$, assume the validity of the result for $k$ and conclude it for $k+1$. Write $k=2 n+i$, with $n \in \mathbb{N}$ and $i \in\{0,1\}$, and consider the operator
$\mathrm{D}^{k}:=(-\Delta)^{n} \nabla^{i}$. Using classic Leibniz formula for integer differentiation, it is not difficult to check that

for some coefficients $C_{j_{1}, j_{2}}$ and with $j_{1}$ and $j_{2}$ multi-indexes with order ranging as described in the sums. Thus, applying $(1+(-\Delta))^{\frac{1}{2}} \mathrm{D}^{k}$ to the Boltzmann equation one gets

Let us control the terms on the right side of (48) starting with the sum. Using the commutator Lemmas 4.1 and 4.2

\end{aligned}

Therefore, for $r \in(0, a)$ and $\alpha \in(0,1]$ it holds that

\begin{aligned}
& \left\|e^{r\langle\cdot\rangle^{\alpha}}(1+(-\Delta))^{\frac{1}{2}} Q\left(\partial^{j_{1}} \nabla^{i} f, \partial^{j_{2}} f\right)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)} \\
& \leq\left\|e^{r\langle\cdot\rangle^{\alpha}} Q\left((1+(-\Delta))^{\frac{1}{2}} \partial^{j_{1}} \nabla^{i} f, \partial^{j_{2}} f\right)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}+\| e^{r\langle\cdot\rangle^{\alpha} \mathcal{I}^{+}\left(\partial^{j_{1}} \nabla^{i} f, \partial^{j_{2}} f\right) \|_{L^{2}\left(\mathbb{R}^{d}\right)}, ~} \\
& +\left\|e^{r\langle\cdot\rangle^{\alpha}} \mathcal{I}^{-}\left(\partial^{j_{1}} \nabla^{i} f, \partial^{j_{2}} f\right)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)} \\
& \leq C\|b\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}\left\|e^{r^{+}\langle\cdot\rangle^{\alpha}}(1+(-\Delta))^{\frac{1}{2}} \partial^{j_{1}} \nabla^{i} f\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}\left\|e^{r^{+}\langle\cdot\rangle^{\alpha}} \partial^{j_{2}} f\right\|_{L^{2}\left(\mathbb{R}^{d}\right)} .
\end{aligned}
$$

Observe that in this $L^{2}-L^{2}$ estimate we paid a small price in the weight $e^{r \cdot \cdot\rangle^{\alpha}} \rightarrow e^{r+}\langle\cdot\rangle^{\alpha}$ since the natural estimate from Young's inequality is an $L^{2}-L^{1}$ estimate. Furthermore, using the commutator Lemma 6.4, it follows for $\alpha \in(0,1]$ that

As a consequence, multiplying equation (48) by $e^{2 r \zeta\rangle}(1+(-\Delta))^{\frac{1}{2}} \mathrm{D}^{k} f$ and using CauchySchwarz inequality together with estimates (49), (50) and (51), one finds a constant $C\left(f_{0}\right)$ depending on lower order norms of $f_{0}$ such that

$$

This proves the case $k \in \mathbb{N}$ after observing that

When $k \in \mathbb{R}^{+} \backslash \mathbb{N}$, write $k=\lfloor k\rfloor+s$ with $s \in(0,1)$. Then, by previous argument

Perform, again, previous argument for the operator $(1+(-\Delta))^{\frac{s}{2}} \mathrm{D}^{\lfloor k\rfloor}$ to conclude the proof.

Corollary 4.1. Assume $\gamma \in[0,1], k \geq 0$, and $\alpha \in(0,1]$. Also,

The constant depends as $C\left(f_{0}\right):=C\left(f_{0}, \gamma, k, r, \alpha\right)$ and lower order $H_{\text {exp }}^{k^{-}}\left(\mathbb{R}^{d}\right)$ Sobolev norms of $f_{0}$.

Proof. This is a direct consequence of Theorem 4.2 and the techniques presented in Theorems 3.1 and 3.3, for hard potentials and Maxwell molecules respectively, to show $L^{\infty}$-norm propagation based on the $L^{2}$-norm propagation.

## 5. Convergence towards equilibrium and decomposition theorem

In this last section we are interested in studying the convergence of the solution of the homogeneous Boltzmann equation with hard potentials towards the Maxwellian distribution and its propagation of smoothness and singularities.

Let us start introducing the relative entropy

$$

and the entropy production

\mathcal{D}(f)=\frac{1}{4} \int_{\mathbb{R}^{2 d}} \int_{\mathbb{S}^{d-1}}\left(f^{\prime} f_{*}^{\prime}-f f_{*}\right) \log \left(\frac{f^{\prime} f_{*}^{\prime}}{f f_{*}}\right) B(u, \widehat{u} \cdot \sigma) \mathrm{d} \sigma \mathrm{~d} v_{*} \mathrm{~d} v .
$$

The function $\mathcal{M}_{f}$ is the thermodynamical equilibrium

$$
\mathcal{M}_{f}(v):=\frac{\rho_{f}}{\left(2 \pi T_{f}\right)^{\frac{d}{2}}} e^{-\frac{\left|v-\mu_{f}\right|^{2}}{2 T_{f}}},
$$

where $\rho_{f}:=\int f$ is the density, $\mu_{f}:=\frac{1}{\rho} \int f v$ is the momentum, and $T_{f}:=\frac{1}{d \rho} \int f|v-\mu|^{2}$ the temperature associated to $f$. Clearly, for the Boltzmann flow $\mathcal{M}_{f}=\mathcal{M}_{f_{0}}$ and

$$
0 \leq \mathcal{H}\left(f \mid \mathcal{M}_{f}\right) \leq \mathcal{H}\left(f_{0} \mid \mathcal{M}_{f_{0}}\right)
$$

In the sequel, and without loss of generality, we assume $\rho=1$ and $\mu=0$. We refer the reader to [38] for additional details and references.

### 5.1. Dissipation of Entropy.

Theorem 5.1. Let the scattering kernel satisfy

(i) If $f \in L^{p}\left(\mathbb{R}^{d}\right)$, with $p \in(1, \infty]$,

\mathcal{D}(f) \geq A_{\varepsilon, p}(f) \mathcal{H}\left(f \mid \mathcal{M}_{f}\right)^{(1+\varepsilon)\left(1+\frac{\gamma p^{\prime}}{d}\right)}
$$

where the constant $A_{\varepsilon, p}(f)$ is given in (56).
(ii) If $f \in L \log L\left(\mathbb{R}^{d}\right)$, then

\mathcal{D}(f) \geq A_{\varepsilon, L \log L}(f) \mathcal{H}\left(f \mid \mathcal{M}_{f}\right)^{(1+\varepsilon)\left(1+\frac{\gamma}{d}\right)} e^{-\frac{\left.2 \gamma \tilde{K}_{L \log } L f\right)}{d K_{\varepsilon}(f) \mathcal{H}\left(f \mid \mathcal{M}_{f}\right)^{1+\varepsilon}}}
$$

where the constant $A_{\varepsilon, L \log L}(f)$ is given in (60).
Proof. Note that

As a consequence, $\mathcal{D}(f) \geq \mathcal{D}_{1}(f)-\mathcal{D}_{2}(f)$ where $\mathcal{D}_{i}(f)$, with $i \in\{1,2\}$, corresponds to each term on the right side of (52) respectively. Using [38, Theorem 3.1] one has

An explicit form for $K_{\varepsilon}(f)$ can be found in [38]. We just mention here that it depends on mass and temperature (energy) of $f$, the parameters $A_{o}, K_{o}, q_{o}$, and

\end{align*}
$$

Case $f \in L^{p}\left(\mathbb{R}^{d}\right)$ : Since, by Hölders inequality,

one concludes from (54) that

\mathcal{D}_{2}(f) \leq C K_{B} R^{\gamma+\frac{d}{p^{\prime}}}\|f\|_{L^{p}\left(\mathbb{R}^{d}\right)}\left(\int_{\mathbb{R}^{d}} f|\log (f)| \mathrm{d} v+\int_{\mathbb{R}^{d}} f\langle v\rangle^{q_{o}} \mathrm{~d} v\right)=: R^{\gamma+\frac{d}{p^{\prime}}} \widetilde{K}_{p}(f) \tag{55}
\end{equation*}

where $C>0$ is a universal constant. Gathering (53) and (55) it follows that

\mathcal{D}(f) \geq R^{\gamma}\left(K_{\varepsilon}(f) \mathcal{H}\left(f \mid \mathcal{M}_{f}\right)^{1+\varepsilon}-R^{\frac{d}{p^{\prime}}} \widetilde{K}_{p}(f)\right)
$$

Choosing $R^{\frac{d}{p^{\prime}}}:=\frac{K_{\varepsilon}(f)}{2 \widetilde{K}_{p}(f)} \mathcal{H}\left(f \mid \mathcal{M}_{f}\right)^{1+\varepsilon}$ it follows that

\mathcal{D}(f) \geq \frac{K_{\varepsilon}(f)^{1+\frac{\gamma p^{\prime}}{d}}}{2^{1+\frac{\gamma p^{\prime}}{d}} \widetilde{K}_{p}(f)^{\frac{\gamma p^{\prime}}{d}}} \mathcal{H}\left(f \mid \mathcal{M}_{f}\right)^{(1+\varepsilon)\left(1+\frac{\gamma p^{\prime}}{d}\right)}=: A_{\varepsilon, p}(f) \mathcal{H}\left(f \mid \mathcal{M}_{f}\right)^{(1+\varepsilon)\left(1+\frac{\gamma p^{\prime}}{d}\right)} . \tag{56}
\end{equation*}
$$

Case $f \in L \log L\left(\mathbb{R}^{d}\right)$ : Using the generalized Young's inequality, see for example the proof of [ 9 , Proposition A.1], one concludes that

where $\mathcal{W}(x)$ is the Lambert function, that is, $\mathcal{W}^{-1}(x)=x e^{x}$. Therefore, recalling (54)

& =: \frac{R^{\gamma} \widetilde{K}_{L \log L}(f)}{\mathcal{W}\left(\frac{\int_{\mathbb{R}^{d}}|\log (f)| \mathrm{d} v}{|\{|v| \leq R\}|}\right)} . \tag{58}
\end{align*}

Using (53) and (58)

\end{equation*}

Now choose, $R>0$ such that

we obtain

& =\frac{K_{\varepsilon}(f)^{1+\frac{\gamma}{d}}}{2^{1+\frac{\gamma}{d}}}\left(\frac{d \int_{\mathbb{R}^{d}} f|\log (f)| \mathrm{d} v}{\left|\mathbb{S}^{d-1}\right| \widetilde{K}_{L \log L}(f)}\right)^{\frac{\gamma}{d}} \mathcal{H}\left(f \mid \mathcal{M}_{f}\right)^{(1+\varepsilon)\left(1+\frac{\gamma}{d}\right)} e^{-\frac{2 \gamma \tilde{K}_{L \log L}(f)}{d K_{\varepsilon}(f) \mathcal{H}\left(f \mid \mathcal{M}_{f}\right)^{1+\varepsilon}}}  \tag{60}\\
& =A_{\varepsilon, L \log L}(f) \mathcal{H}\left(f \mid \mathcal{M}_{f}\right)^{(1+\varepsilon)\left(1+\frac{\gamma}{d}\right)} e^{-\frac{2 \gamma \tilde{K}_{L \log L}(f)}{d K_{\varepsilon}(f) \mathcal{H}\left(f \mid \mathcal{M}_{f}\right)^{1+\varepsilon}}} .
\end{align*}

### 5.2. Entropic moments and transitory relaxation.

Proposition 5.1. Assume $f$ is solution of the homogeneous Boltzmann problem for hard potentials with initial data satisfying (5). Then, for any $t_{o}>0$ and $s \in[0, \infty)$

\sup _{t \geq t_{o}} \int_{\mathbb{R}^{d}} f(v)\langle v\rangle^{s}|\log (f)| d v<\infty .
$$

Proof. The case $s=0$ is clear. Thus, multiply the equation by $\langle v\rangle^{s}|\log (f)|$, with $s>0$, to obtain

For the second term on the right side it readily follows that

\left|\int_{\mathbb{R}^{d}} Q(f, f)(v)\langle v\rangle^{s} \operatorname{sgn}(\log (f)) \mathrm{d} v\right| \leq 2\|b\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}\left\|f\langle v\rangle^{\gamma+s}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}\left\|f\langle v\rangle^{\gamma+s}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)} \tag{61}
\end{equation*}
$$

The first term has a positive and negative parts. For the negative, one concludes using the uniform boundedness of entropy that

where $c_{o}>0$ is a constant depending of the initial entropy, mass and energy. For the positive part, one has

\int_{\mathbb{R}^{d}} Q^{+}(f, f)(v)\langle v\rangle^{s}|\log (f)| \mathrm{d} v=\int_{\mathbb{R}^{2 d}} f(v) f\left(v_{*}\right)|u|^{\gamma} \int_{\mathbb{S}^{d-1}}\left|\log \left(f\left(v^{\prime}\right)\right)\right|\left\langle v^{\prime}\right\rangle^{s} b(\widehat{u} \cdot \sigma) \mathrm{d} \sigma \mathrm{~d} v_{*} \mathrm{~d} v  \tag{63}\\
\leq C_{s} \int_{\mathbb{R}^{2 d}} \sum_{(i, j)} f(v)\langle v\rangle^{i} f\left(v_{*}\right)\left\langle v_{*}\right\rangle^{j} \int_{\mathbb{S}^{d-1}}\left|\log \left(f\left(v^{\prime}\right)\right)\right| b(\widehat{u} \cdot \sigma) \mathrm{d} \sigma \mathrm{~d} v_{*} \mathrm{~d} v
\end{gather*}
$$

The sum is performed on $(i, j) \in\{(s+\gamma, 0),(s, \gamma),(\gamma, s),(0, s+\gamma)\}$. We estimate the right side in (63) controlling the integral in the integration sets $\left\{f^{\prime} \leq 1\right\}$ and $\left\{f^{\prime}>1\right\}$ separately. For the former recall the classical result proved in [37]: for any $t_{o}>0$ there exists positive $K_{o}, A_{o}$ depending only on the initial mass, energy, entropy and $t_{o}$ such that

\end{equation*}

The latter set $\left\{f^{\prime}>1\right\}$ is trickier. We concentrate first on the combination $(i, j)=(0, s+\gamma)$ since the others follow a simpler argument. First, we fix $\varepsilon>0$ and use the usual angular split (3). In each component we use the generalized Young's inequality

in slightly, but crucially, different way. For the good part, the one with $b_{1}^{\varepsilon}(\cos \theta)$, we choose $x=f(v)$ and $y=\left|\log \left(f^{\prime}\right)\right| 1_{f^{\prime}>1}$ to get

& \leq\left\|b_{1}^{\varepsilon}\right\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}\left\|f\langle v\rangle^{s+\gamma}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}\|f \log (f)\|_{L^{1}\left(\mathbb{R}^{3}\right)}  \tag{65}\\
& \quad+2^{d}\left\|\frac{b_{1}^{\varepsilon}(\cos (\theta))}{1-\cos (\theta)}\right\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}\left\|f\langle v\rangle^{s+\gamma}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}\|f\|_{L^{1}\left(\mathbb{R}^{d}\right)}
\end{align*}
$$

where we have used the singular change of variable $v \rightarrow v^{\prime}$ in the integral containing $f^{\prime}$. For the bad part, the one with $b_{2}^{\varepsilon}(\cos \theta)$, we choose $x=\left\langle v_{*}\right\rangle^{s+\gamma} f\left(v_{*}\right)$ and $y=\left|\log \left(f^{\prime}\right)\right| 1_{f^{\prime}>1}$ to get

& \leq\left\|b_{2}^{\varepsilon}\right\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}\left(\left\|f\langle v\rangle^{s+\gamma} \log (f)\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}\|f\|_{L^{1}\left(\mathbb{R}^{3}\right)}\right.  \tag{66}\\
& \left.+(s+\gamma)\left\|f\langle v\rangle^{s+\gamma} \log \langle v\rangle\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}\|f\|_{L^{1}\left(\mathbb{R}^{3}\right)}\right)+2^{d}\left\|\frac{b_{2}^{\varepsilon}(\cos (\theta))}{1+\cos (\theta)}\right\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}\|f\|_{L^{1}\left(\mathbb{R}^{d}\right)}^{2}
\end{array}
$$

where we used the change of variable $v_{*} \rightarrow v^{\prime}$ in the integral containing $f^{\prime}$. Of course, in this case it is harmless since $b(\cdot)$ is supported in $[0,1]$. Furthermore, we recall that $\left\|b_{2}^{\varepsilon}\right\|_{L^{1}\left(\mathbb{S}^{d-1}\right)} \sim \mathfrak{m}\left(b_{2}^{\varepsilon}\right)$ can be made as small as desired.

For the rest of the cases one does not need to split the kernel in two. It suffices to choose $x=f\left(v_{*}\right)\left\langle v_{*}\right\rangle^{s}$ when $(i, j)=(\gamma, s), x=f\left(v_{*}\right)\left\langle v_{*}\right\rangle^{\gamma}$ when $(i, j)=(s, \gamma)$, and $x=f\left(v_{*}\right)$ when $(i, j)=(s+\gamma, 0)$. In all cases $y=\left|\log \left(f^{\prime}\right)\right| 1_{f^{\prime}>1}$. Furthermore, the resulting lower order entropic moments can be controlled as

In summary, after gathering (63), (64), (65), (66) and (67) one concludes

& \quad+C_{1}(f)\left\|f \log (f)\langle v\rangle^{s+\gamma}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}^{\frac{\gamma}{s+\gamma}}+C_{2}(f)\left\|f \log (f)\langle v\rangle^{s+\gamma}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}^{\frac{s}{s+\gamma}}+C_{3}^{\varepsilon}(f),
\end{align*}
$$

where the constants $C_{i}(f)$, with $i=1,2,3$, depend on the mass, temperature, initial entropy and $\left\|f\langle v\rangle^{s+\gamma+2}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}$. Now, choose $\varepsilon$ such that $\mathfrak{m}\left(b_{2}^{\varepsilon}\right) \leq \frac{c_{o}}{2}$ and use the estimates
(61), (62) and (63) to get

& \frac{\mathrm{d}}{\mathrm{~d} t}\left\|f \log (f)\langle v\rangle^{s}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)} \leq C_{1}(f)\left\|f \log (f)\langle v\rangle^{s+\gamma}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}^{\frac{\gamma}{s+\gamma}} \\
& \quad+C_{2}(f)\left\|f \log (f)\langle v\rangle^{s+\gamma}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}^{\frac{s}{s+\gamma}}+C_{3}^{\varepsilon}(f)-\frac{c_{o}}{2}\left\|f \log (f)\langle v\rangle^{s+\gamma}\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}
\end{aligned}
$$

The result follows from here after invoking the instantaneous appearance of moments proven in [42].

Proposition 5.2. Assume $f$ is solution of the homogeneous Boltzmann problem for hard potentials with initial data satisfying (5). Then, for any $\varepsilon>0$

\mathcal{H}\left(f \mid \mathcal{M}_{f}\right) \leq C_{\varepsilon}\left(f_{0}\right)(\ln (e+t))^{-\frac{1}{1+\varepsilon}},
$$

with constant $C_{\varepsilon}\left(f_{0}\right)$ depending on mass, temperature, and entropy of $f_{0}$. Furthermore, if additionally $f_{0} \in L^{p}\left(\mathbb{R}^{d}\right)$, with $p \in(1, \infty]$, then

\mathcal{H}\left(f \mid \mathcal{M}_{f}\right) \leq C_{\varepsilon}\left(f_{0}\right)(1+t)^{-\frac{1}{\frac{\gamma p^{\prime}}{d}+\varepsilon\left(1+\frac{\gamma p^{\prime}}{d}\right)}},
$$

with constant $C_{\varepsilon}\left(f_{0}\right)$ depending additionally of the $L^{p}$-norm of $f_{0}$.
Proof. Let us prove the first statement. Using the appearance of moments [42] and entropic moments Proposition 5.1, there exist constants $\mathcal{A}_{o}\left(f_{0}\right)$ and $\mathcal{B}_{o}\left(f_{0}\right)$ only depending on initial mass, temperature, entropy, and $t_{o}>0$ (and $\varepsilon>0$ ) such that

$$

It is not difficult to check that $X(t)=C(\ln (e+t))^{-\frac{1}{1+\varepsilon}}$ satisfies

\frac{\mathrm{d}}{\mathrm{~d} t} X+\mathcal{A}_{o}\left(f_{0}\right) X^{(1+\varepsilon)\left(1+\frac{\gamma}{d}\right)} e^{-\frac{\mathcal{B}_{o}\left(f_{0}\right)}{X^{1+\varepsilon}}} \geq 0
$$

provided $C>0$ is taken large enough depending on $\mathcal{A}_{o}\left(f_{0}\right)$ and $\mathcal{B}_{o}\left(f_{0}\right)$. Denote any such value as $C_{*}$ and choose $C=C\left(f_{0}\right):=\max \left\{\mathcal{H}\left(f_{0} \mid \mathcal{M}_{f_{0}}\right), C_{*}\right\}$. Since $\mathcal{H}\left(f\left(t_{o}\right) \mid \mathcal{M}_{f\left(t_{o}\right)}\right) \leq$ $\mathcal{H}\left(f_{0} \mid \mathcal{M}_{f_{0}}\right)$ the result follows by a comparison principle. The second statement follows similar argument and it is left to the reader.
5.3. Exponential convergence. After fixing the initial mass, momentum, and temperature, one can rewrite the Boltzmann equation (1) by taking $f=\mathcal{M}_{f_{0}}+h$, where $h$ is understood as a perturbation of the thermodynamical equilibrium. The equation for $h$ reads

\partial_{t} h(v)=\mathcal{L}(h)(v)+Q(h, h)(v), \quad(t, v) \in \mathbb{R}^{+} \times \mathbb{R}^{d} \tag{69}
\end{equation*}
$$

Here, the linear component of the dynamics is generated by the operator

$$
\begin{equation*}
\mathcal{L}(h)(v)=Q\left(\mathcal{M}_{f_{0}}, h\right)+Q\left(h, \mathcal{M}_{f_{0}}\right) . \tag{70}
\end{equation*}
$$

This operator was shown to be self-adjoint non-positive with a spectral gap in $L^{2}\left(\mathcal{M}_{f_{0}}^{-1 / 2}\right)$ in the references [19], [26] and [27] in the cut-off case. Later, allowing more general kernels,
an explicit estimate of the spectral gap in this same space was made in [34]. This is the starting point at which the spectral enlargement technique works [33, 29] to obtain spectral gap in more general spaces.

Based on [29, Theorem 2.3] or [18, Theorem 3.1], if a spectral enlargement from $L^{2}\left(\mathcal{M}_{f_{0}}^{-1 / 2}\right)$ to $L_{k}^{1}$ is desired, we need to decompose the linearized operator $\mathcal{L}$ into two operators with suitable properties. More precisely, $\mathcal{L}=\mathcal{A}+\mathcal{B}$ where $\mathcal{B}: L_{k}^{1}\left(\mathbb{R}^{d}\right) \rightarrow L_{k}^{1}\left(\mathbb{R}^{d}\right)$ is dissipative ${ }^{2}$ and $\mathcal{A}: L_{k}^{1}\left(\mathbb{R}^{d}\right) \rightarrow L^{2}\left(\mathcal{M}_{f_{0}}^{-1 / 2} ; \mathbb{R}^{d}\right)$ is bounded. Here we stress that the space $L^{2}\left(\mathcal{M}_{f_{0}}^{-1 / 2} ; \mathbb{R}^{d}\right)$ is taken as baseline space since a detailed quantification of the spectrum is available in the aforementioned references.

The decomposition is based on truncation of small and large velocities, and glancing angles (similar but simpler to the decomposition given in [29, subsection 4.3.3] or [33]). For the scattering kernel, recall the decomposition we have used along the document

b(\cos (\theta))=b(\cos (\theta))\left(1_{|\sin (\theta)| \geq \varepsilon}+1_{|\sin (\theta)|<\varepsilon}\right)=: b_{1}^{\varepsilon}(\cos (\theta))+b_{2}^{\varepsilon}(\cos (\theta)) . \tag{71}
\end{equation*}
$$

For the kinetic potential write $|\cdot|^{\gamma}=: \Phi_{1}+\Phi_{2}$, where

With the notation $\mathcal{L}_{\Phi, b}$ to express the dependence of the collision kernel, one can write

& =\mathcal{L}_{\Phi_{1}, b_{1}^{\varepsilon}}^{o} h+\left(\mathcal{L}_{\Phi_{2}, b_{1}^{\varepsilon}}^{o} h+\mathcal{L}_{x^{\gamma}, b_{2}^{\varepsilon}} h-h \int_{\mathbb{R}^{d}} \mathcal{M}_{f_{0}}\left(v_{*}\right)|u|^{\gamma} \mathrm{d} v_{*}\right)=: \mathcal{A}_{\delta, \varepsilon} h+\mathcal{B}_{\delta, \varepsilon} h \tag{73}

Let us prove that $\mathcal{B}_{\delta, \varepsilon}$ is dissipative for sufficiently small parameters $\delta>0, \varepsilon>0$ and that $\mathcal{A}_{\delta, \varepsilon}$ has the stated "regularizing" property for any $\delta>0, \varepsilon>0$. For the first statement, one essentially needs the following lemma controlling moments of the linearized operator.
Lemma 5.1. Consider angular kernel $b \in L^{1}\left(\mathbb{S}^{d}\right)$ and potential $0 \leq \Phi(|u|) \leq|u|^{\gamma}$. Then for any $h \in L_{k+\gamma}^{1}\left(\mathbb{R}^{d}\right)$ and any $k \geq 2$

\end{aligned}

Here above, $0<\gamma_{k}<\|b\|_{L^{1}\left(\mathbb{S}^{d-1}\right)}=1$ is such that $\gamma_{k} \searrow 0$ as $k \rightarrow \infty$. And,

Lemma 5.2. Consider angular kernel $b \in L^{1}\left(\mathbb{S}^{d}\right)$ and potentials with $\gamma \in(0,1]$. For $\varepsilon \in(0,1), \delta \in(0,1)$ and $k \geq 2$, it follows that

The constant $C_{k}>0$ in addition to $k$, depends on mass and temperature. The constant $c_{o}$ depends only on mass and temperature.

Proof. First, let us estimate $\mathcal{L}_{x^{\gamma}, b_{2}^{\varepsilon}}$ and $\mathcal{L}_{\Phi_{2}, b_{1}^{\varepsilon}}^{o}$ separately. For the former, using Lemma 5.1 one readily concludes

We used, for the second inequality, that $\beta_{x^{\gamma}}(v) \leq \widetilde{C}_{k}\langle v\rangle^{\gamma}$ and $\left\|b_{2}^{\varepsilon}\right\|_{L^{1}\left(\mathbb{S}^{d-1}\right)} \sim \mathfrak{m}\left(b_{2}^{\varepsilon}\right)$. We used, in the second inequality, the fact that $b_{2}^{\varepsilon} \leq b$ and that $\beta_{\Phi_{2}}(v) \leq \widetilde{C}_{k} \delta^{\gamma}\langle v\rangle^{1+\gamma}$. Second, for the dissipation term, one uses that

The result follows after gathering (75), (76), (78).

Corollary 5.1. There exists positive $\left(\delta_{k}, \varepsilon_{k}\right)$ depending on mass and temperature such that $\mathcal{B}_{\delta, \varepsilon}$ is dissipative in $L_{k}^{1}\left(\mathbb{R}^{d}\right)$ for any $\delta \in\left(0, \delta_{k}\right)$ and $\varepsilon \in\left(0, \varepsilon_{k}\right)$. Furthermore, for any $c_{o}^{-}<c_{o}$, given in (77), it is possible to find $(\delta, \varepsilon)$ in such ranges and such that

Here $\widetilde{\delta}+\widetilde{\varepsilon}$ is allowed to be as small as desired. This is exactly (79).
Lemma 5.3. For any $\delta \in(0,1)$ and $\varepsilon \in(0,1)$ and $k \geq 2$, the operator $\mathcal{A}_{\delta, \varepsilon}: L_{k}^{1}\left(\mathbb{R}^{d}\right) \rightarrow$ $L^{2}\left(\mathcal{M}_{f_{0}}^{-1 / 2}\right)$ is bounded.
Proof. Let us estimate each term separately in $\mathcal{A}_{\delta, \varepsilon}=\mathcal{L}_{\Phi_{1}, b_{1}^{\varepsilon}}^{o}$, recall (74). It is direct that the last term is controlled by

\end{align*}

In addition, since $b_{1}^{\varepsilon}$ is cut-off near zero angle and (setting $x=v_{*}^{\prime}=v-u^{+}$and $y=u^{+}$ above)

& \leq \widetilde{C}\left(b_{1}^{\varepsilon}\right)\left\|\mathcal{M}_{f_{0}}^{-3 / 2}(u) \Phi_{1}\right\|_{L^{\infty}\left(\mathbb{R}^{d}\right)}\left\|\mathcal{M}_{f_{0}}^{1 / 4}\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}\|h\|_{L^{1}\left(\mathbb{R}^{d}\right)} \tag{82}
\end{align*}
$$

The result follows, after gathering (80), (81) and (82).
Proposition 5.3. Let $b \in L^{1}\left(\mathbb{S}^{d-1}\right)$ and $\gamma \in(0,1]$ and $k \geq 2$. The linear operator $\mathcal{L}$ defined in $L_{k}^{1}\left(\mathbb{R}^{d}\right)$ satisfies

\end{gathered}
$$

for any $\lambda<\lambda_{o}$ where $\lambda_{o}$ is the spectral gap of the restriction of $\mathcal{L}$ to $L^{2}\left(\mathcal{M}_{f_{0}}^{-1 / 2} ; \mathbb{R}^{d}\right)$. Furthermore, it generates a strongly continuous semigroup $e^{t \mathcal{L}}$ which satisfies

Finally, we arrive to the exponential convergence of the full homogeneous Boltzmann equation (69). Let $f:=f(t, v)$ be solution of the Boltzmann equation, $\mathcal{M}_{f_{0}}$ its thermodynamical equilibrium, and set the perturbation $f:=\mathcal{M}_{f_{0}}+h$. The first step is to invoke Csiszár-Kullback-Pinsker inequality to deduce that

Here, the constant $C_{k}\left(f_{0}\right)>0$ only depends on the initial datum through its mass, temperature and entropy. In this way, for every $\varepsilon \in(0,1)$ there exists time $t_{k}\left(f_{0}\right)$ such that

\|Q(\tilde{h}, \tilde{h})(s)\|_{L_{k}^{1}\left(\mathbb{R}^{d}\right)} \leq\|\tilde{h}(s)\|_{L_{k+\gamma}^{1}\left(\mathbb{R}^{d}\right)}^{2} \leq\|\tilde{h}(s)\|_{L_{k}^{1}\left(\mathbb{R}^{d}\right)}\|\tilde{h}(s)\|_{L_{k+2 \gamma}^{1}\left(\mathbb{R}^{d}\right)} \leq \varepsilon\|\tilde{h}(s)\|_{L_{k}^{1}\left(\mathbb{R}^{d}\right)} .
$$

As a consequence, setting $X(t):=e^{\lambda t}\|\tilde{h}(t)\|_{L_{k}^{1}\left(\mathbb{R}^{d}\right)}$, we obtain from (84)

$$
X(t) \leq X_{0}+\varepsilon \int_{0}^{t} X(s) \mathrm{d} s, \quad t \geq 0
$$

Using Gronwall's lemma one concludes that $X(t) \leq X_{0} e^{\varepsilon t}$, or equivalently,

$$
\|\tilde{h}(t)\|_{L_{k}^{1}\left(\mathbb{R}^{d}\right)} \leq\left\|\tilde{h}_{0}\right\|_{L_{k}^{1}\left(\mathbb{R}^{d}\right)} e^{-(\lambda-\varepsilon) t}, \quad t \geq 0 .
$$

We have proven the main result of this section
Theorem 5.2 (Exponential relaxation). Let the angular kernel satisfy (4) and potential $\gamma \in(0,1]$. Assume the initial datum $f_{0}$ satisfies (5). Then, for every $\lambda<\lambda_{o}$, there exists time $t_{k}\left(f_{0}\right)$ and $C_{k}\left(f_{0}\right)$ depending on the initial datum through its mass, temperature and entropy, such that

$$
\left\|f-\mathcal{M}_{f_{0}}\right\|_{L_{k}^{1}\left(\mathbb{R}^{d}\right)} \leq C_{k}\left(f_{0}\right) e^{-\lambda t}, \quad t \geq t_{k}\left(f_{0}\right)
$$

Here $\lambda_{o}>0$ is the spectral gap of $\mathcal{L}$ in $L^{2}\left(\mathcal{M}_{f_{0}}^{-1 / 2} ; \mathbb{R}^{d}\right)$.
Theorem 5.2 gives, straightforwardly, the decomposition theorem [35, Theorem 5.5] related to the propagation of roughness for the Homogeneous Boltzmann equation.

Corollary 5.2 (Decomposition theorem). Let the angular kernel satisfy (4) and potential $\gamma \in(0,1]$. Assume the initial datum $f_{0}$ satisfies (5). For any $s, k \geq 0$ and $t_{o}>0$ there exist functions $f^{S} \geq 0$ and $f^{R}$ such that

$$
f=f^{S}+f^{R}, \quad t \geq t_{o}>0
$$

satisfying the estimates

$$
\sup _{t \geq t_{o}}\left\|f^{S}(t)\right\|_{H_{k}^{s}\left(\mathbb{R}^{d}\right)}<C_{s, k}\left(t_{o}\right), \quad\left\|f^{R}(t)\right\|_{L_{k}^{1}\left(\mathbb{R}^{d}\right)} \leq C_{k}\left(t_{o}\right) e^{-\lambda t}, \quad \lambda<\lambda_{o} .
$$

The constants depend on mass, energy, and entropy of $f_{0}$.

Proof. Choose $f^{S}:=\mathcal{M}_{f_{0}}$ and $f^{R}:=f-\mathcal{M}_{f_{0}}$, and use the exponential relaxation given in Theorem 5.2 for $f^{R}$.
Remark 5.1. In the context of the homogenous Boltzmann problem, the decomposition theorem loses its value since it is an obvious consequence of Theorem 5.2. However, the techniques to prove it given in [35, Theorem 5.5] continue being useful in other contexts.

## 6. Appendix

6.1. Young's inequality for the gain collision operator. The proof of the following theorem can be found in [3, Theorem 1].

Theorem 6.1. Let $1 \leq p, q, r \leq \infty$ with $1 / p+1 / q=1+1 / r$. Assume that

$$
B(x, y)=x^{\gamma} b(y), \quad \gamma \geq 0
$$

Then, for any $k \geq 0$

$$
\left\|Q^{+}(f, g)\right\|_{L_{k}^{r}} \leq C\|f\|_{L_{k+\gamma}^{p}}\|g\|_{L_{k+\gamma}^{q}}
$$

where, whenever finite, the constant $C:=C(b)$ can be taken as

$$
\begin{equation*}
C=K\left(\int_{0}^{1}\left(\frac{1-s}{2}\right)^{-\frac{d}{2 r^{\prime}}}\left(1-s^{2}\right)^{\frac{d-3}{2}} b(s) d s\right)^{\frac{r^{\prime}}{q^{\prime}}}\left(\int_{0}^{1}\left(\frac{1+s}{2}\right)^{-\frac{d}{2 r^{\prime}}}\left(1-s^{2}\right)^{\frac{d-3}{2}} b(s) d s\right)^{\frac{r^{\prime}}{p^{\prime}}} \tag{85}
\end{equation*}
$$

with $K:=2^{k+\gamma+3}\left|\mathbb{S}^{d-2}\right|$. In the particular cases that $p=1$ or $q=1$, the constant is interpreted as

$$
\begin{align*}
& C=K \int_{0}^{1}\left(\frac{1-s}{2}\right)^{-\frac{d}{2 q^{\prime}}}\left(1-s^{2}\right)^{\frac{d-3}{2}} b(s) d s, \quad \text { when } p=1 \\
& C=K \int_{0}^{1}\left(\frac{1+s}{2}\right)^{-\frac{d}{2 p^{\prime}}}\left(1-s^{2}\right)^{\frac{d-3}{2}} b(s) d s, \quad \text { when } q=1 . \tag{86}
\end{align*}
$$

6.2. Fractional differentiation lemmas. In this appendix some identities and estimates are presented when operating with fractional differentiation of products of functions. They will be handy when proving commutator formulas for the collision operator and dealing with exponential or polynomial weights in the Sobolev estimates.

Lemma 6.1. For any $\varepsilon \in(0,1]$ and $a \geq 0$ it holds that

$$
\left|\frac{x}{|x|^{1+a}}-\frac{y}{|y|^{1+a}}\right| \leq 2(1+a)|x-y|^{\varepsilon}\left(\frac{1}{|x|^{a+\varepsilon}}+\frac{1}{|y|^{a+\varepsilon}}\right), \quad x, y \in \mathbb{R}^{d}
$$

Proof. Since the role of the vectors $x$ and $y$ is interchangeable, we assume $|y| \geq|x|$ without loss of generality. Thus, estimating directly the difference yields

Note that

$$
|x-y|=|x-y|^{\varepsilon}|x-y|^{1-\varepsilon} \leq|x-y|^{\varepsilon}\left(|x|^{1-\varepsilon}+|y|^{1-\varepsilon}\right), \quad \varepsilon \in(0,1]
$$

As a consequence, the second term on the right side in (87) can be readily estimated as

$$
\begin{equation*}
\frac{|x-y|}{|y|^{1+a}} \leq|x-y|^{\varepsilon} \frac{|x|^{1-\varepsilon}+|y|^{1-\varepsilon}}{|y|^{1+a}} \leq 2 \frac{|x-y|^{\varepsilon}}{|y|^{a+\varepsilon}} \tag{88}
\end{equation*}
$$

For the first term on the right side in (87), note that

$$
\left||y|^{1+a}-|x|^{1+a}\right| \leq(1+a) \max \left\{|x|^{a},|y|^{a}\right\}|x-y| \leq(1+a)|y|^{a}|x-y|
$$

Thus, bearing in mind that $|y| \geq|x|$, we conclude that

$$
\begin{align*}
\frac{\left||y|^{1+a}-|x|^{1+a}\right|}{|x|^{a}|y|^{1+a}} & \leq(1+a) \frac{|x-y|}{|x|^{a}|y|} \leq(1+a)|x-y|^{\varepsilon} \frac{|x|^{1-\varepsilon}+|y|^{1-\varepsilon}}{|x|^{a}|y|}  \tag{89}\\
& \leq 2(1+a) \frac{|x-y|^{\varepsilon}}{|x|^{a}|y|^{\varepsilon}} \leq 2(1+a) \frac{|x-y|^{\varepsilon}}{|x|^{a+\varepsilon}}
\end{align*}
$$

The lemma follows by gathering (87), (88) and (89).
Lemma 6.2. Let $0 \leq A<B$ and $a \in[0,1)$. Then,

$$
\begin{equation*}
\int_{0}^{1}|-A+\theta B|^{-a} d \theta=\frac{A^{1-a}+(B-A)^{1-a}}{(1-a) B} \tag{90}
\end{equation*}
$$

In particular, for any $\gamma \in(0,1]$ and $v, v_{*}, x \in \mathbb{R}^{d}$

$$
\begin{equation*}
\gamma \int_{0}^{1}\left|v-v_{*}-\theta x\right|^{-(1-\gamma)} d \theta \leq(2-\gamma)\left|v-v_{*}\right|^{-(1-\gamma)} \tag{91}
\end{equation*}
$$

Proof. Estimate (90) is clear. Indeed, break the integral where the integrand is nonpositive and nonnegative, namely, in the intervals $\left(0, \frac{A}{B}\right)$ and $\left(\frac{A}{B}, 1\right)$. Then, perform the integration.

Regarding estimate (91), since $-(1-\gamma) \leq 0$, triangle inequality implies

$$
\begin{aligned}
\int_{0}^{1}\left|v-v_{*}-\theta x\right|^{-(1-\gamma)} \mathrm{d} \theta & =\int_{0}^{1}\left|(1-\theta)\left(v-v_{*}\right)+\theta\left(v-v_{*}-x\right)\right|^{-(1-\gamma)} \mathrm{d} \theta \\
& \leq \int_{0}^{1}|\theta| v-v_{*}-x|-(1-\theta)| v-v_{*}| |^{-(1-\gamma)} \mathrm{d} \theta \\
& =\left.\int_{0}^{1}\left|-\left|v-v_{*}\right|+\theta\right|\left(\left|v-v_{*}-x\right|+\left|v-v_{*}\right|\right)\right|^{-(1-\gamma)} \mathrm{d} \theta .
\end{aligned}
$$

Using (90) with $A=\left|v-v_{*}\right|$ and $B=\left|v-v_{*}-x\right|+\left|v-v_{*}\right|$, it follows that

$$
\begin{aligned}
& \gamma \int_{0}^{1}\left|v-v_{*}-\theta x\right|^{-(1-\gamma)} d \theta \leq \frac{\left|v-v_{*}\right|^{\gamma}+\left|v-v_{*}-x\right|^{\gamma}}{\left|v-v_{*}\right|+\left|v-v_{*}-x\right|} \\
& \leq\left(\sup _{X \geq 0} \frac{1+X^{\gamma}}{1+X}\right) \times\left|v-v_{*}\right|^{-(1-\gamma)} \leq(2-\gamma)\left|v-v_{*}\right|^{-(1-\gamma)}
\end{aligned}
$$

This proves estimate (91).
Lemma 6.3. Let $d \geq 2, \gamma \geq 0, s \in(0,1]$ and $v_{*} \in \mathbb{R}^{d}$. Then, for any suitable function $f$ it follows that

$$
(1+(-\Delta))^{\frac{s}{2}}\left(f \tau_{v_{*}}|\cdot| \gamma\right)=(1+(-\Delta))^{\frac{s}{2}} f \times \tau_{v_{*}}|\cdot|^{\gamma}+\mathcal{R}_{v_{*}}(f),
$$

where $\tau$ is the translation operator. The remainder term is given by

$$
\mathcal{R}_{v_{*}}(f)(v):=s \int_{\mathbb{R}^{d}}\left(\int_{0}^{1} \nabla|\cdot|^{\gamma}\left(v-v_{*}-\theta x\right) d \theta\right) \cdot \nabla \varphi(x) f(v-x) d x
$$

where $\varphi:=\mathcal{F}^{-1}\left\{\langle\cdot\rangle^{s-2}\right\}$ is the Bessel kernel of order $2-s$.
Remark 6.1. In Lemma 6.3 the case $\gamma \in(0,1]$ and $s=1$ is special. In this case write

$$
\begin{align*}
& \mathcal{R}_{v_{*}}(f)(v)=\nabla|\cdot|^{\gamma}\left(v-v_{*}\right) \cdot(\nabla \varphi * f)(v) \\
+ & \int_{\mathbb{R}^{d}}\left(\int_{0}^{1}\left(\nabla|\cdot|^{\gamma}\left(v-v_{*}-\theta x\right)-\nabla|\cdot|^{\gamma}\left(v-v_{*}\right)\right) d \theta\right) \cdot \nabla \varphi(x) f(v-x) d x \tag{92}
\end{align*}
$$

The first term on the right side is a singular integral. Indeed, the conditions

$$
\widehat{\nabla \varphi}(\xi)=\frac{i \xi}{\langle\xi\rangle} \in L^{\infty}\left(\mathbb{R}^{d}\right), \quad \nabla \varphi \in \mathcal{C}^{1}\left(\mathbb{R}^{d} \backslash\{0\}\right), \quad|\Delta \varphi(x)| \leq \frac{C}{|x|^{d+1}}
$$

satisfied by the convolution kernel are sufficient to properly define the convolution as a bounded operator in $L^{p}\left(\mathbb{R}^{d}\right)$ for any $p \in(1, \infty)$, see [28, Chapter 4] for details. We just notice that for the case in question here, the boundedness in $L^{2}\left(\mathbb{R}^{d}\right)$ is trivial since $\widehat{\nabla \varphi} \in$ $L^{\infty}\left(\mathbb{R}^{d}\right)$, thus

$$
\|f * \nabla \varphi\|_{L^{2}\left(\mathbb{R}^{d}\right)}=\|\widehat{\nabla \varphi} \widehat{f}\|_{L^{2}\left(\mathbb{R}^{d}\right)} \leq\|f\|_{L^{2}\left(\mathbb{R}^{d}\right)}
$$

The second term is properly defined as well. Using Lemma 6.1 with $x=v-v_{*}-\theta x$ and $y=v-v_{*}$ one has

$$
\begin{aligned}
& \left.|\nabla| \cdot\right|^{\gamma}\left(v-v_{*}-\theta x\right)-\nabla|\cdot|^{\gamma}\left(v-v_{*}\right) \mid \\
& \quad \leq 2 \gamma(2-\gamma)|\theta x|^{\varepsilon}\left(\frac{1}{\left|v-v_{*}-\theta x\right|^{1-\gamma+\varepsilon}}+\frac{1}{\left|v-v_{*}\right|^{1-\gamma+\varepsilon}}\right), \quad \varepsilon \in(0,1]
\end{aligned}
$$

Choosing $\varepsilon \in(0, \gamma)$ one also has $1-\gamma+\varepsilon<1$, thus, applying (91) it follows that

$$
\begin{gather*}
\left|\int_{\mathbb{R}^{d}}\left(\int_{0}^{1}\left(\nabla|\cdot|^{\gamma}\left(v-v_{*}-\theta x\right)-\nabla|\cdot|^{\gamma}\left(v-v_{*}\right)\right) d \theta\right) \cdot \nabla \varphi(x) f(v-x) d x\right|  \tag{93}\\
\leq \frac{C}{\left|v-v_{*}\right|^{1-\gamma+\varepsilon}}\left(\left.| | \cdot\right|^{\varepsilon} \nabla \varphi|*| f \mid\right)(v)
\end{gather*}
$$

Then, this term is well-defined since $\left||\cdot|{ }^{\varepsilon} \nabla \varphi\right| \in L^{1}\left(\mathbb{R}^{d}\right)$.
Proof. Let $g(\cdot)=\tau_{v_{*}}|\cdot|^{\gamma}$ and note that

$$
\begin{aligned}
& \mathcal{F}\left\{(1+(-\Delta))^{\frac{s}{2}}(f g)\right\}(\xi)=\langle\xi\rangle^{s}(\widehat{f} * \widehat{g})(\xi) \\
& \quad=\mathcal{F}\left\{(1+(-\Delta))^{\frac{s}{2}} f \times g\right\}(\xi)+\int_{\mathbb{R}^{d}}\left(\langle\xi\rangle^{s}-\langle\xi-x\rangle^{s}\right) \widehat{g}(x) \widehat{f}(\xi-x) \mathrm{d} x
\end{aligned}
$$

Now, the identity

$$
\langle\xi\rangle^{s}-\langle\xi-x\rangle^{s}=-\int_{0}^{1} \frac{\mathrm{~d}}{\mathrm{~d} \theta}\langle\xi-\theta x\rangle^{s} \mathrm{~d} \theta=s \int_{0}^{1} \frac{(\xi-\theta x) \cdot x}{\langle\xi-\theta x\rangle^{2-s}} \mathrm{~d} \theta
$$

leads to the definition of the remainder

$$
\begin{aligned}
& \int_{\mathbb{R}^{d}}\left(\langle\xi\rangle^{s}-\langle\xi-x\rangle^{s}\right) \widehat{g}(x) \widehat{f}(\xi-x) \mathrm{d} x \\
&=s \int_{0}^{1} \int_{\mathbb{R}^{d}} \widehat{\nabla g}(x) \cdot \frac{-i(\xi-\theta x)}{\langle\xi-\theta x\rangle^{2-s}} \widehat{f}(\xi-x) \mathrm{d} x \mathrm{~d} \theta=: \widehat{\mathcal{R}_{v_{*}}(f)}(\xi)
\end{aligned}
$$

In addition, using properties of the Fourier transform yields

$$
\mathcal{F}^{-1}\left\{\frac{-i(\cdot-\theta x) \widehat{f}(\cdot-x)}{\langle\cdot-\theta x\rangle^{2-s}}\right\}(v)=e^{i x \cdot v}(f * \phi)(v), \quad \phi:=-e^{-i(1-\theta) x \cdot} \nabla \mathcal{F}^{-1}\left\{\langle\cdot\rangle^{s-2}\right\}
$$

Thus, plugging in the definition of $\mathcal{R}_{v_{*}}(f)$ one gets

$$
\begin{align*}
\mathcal{R}_{v_{*}}(f)(v)=s \int_{0}^{1} & \int_{\mathbb{R}^{d}} \widehat{\nabla g}(x) \cdot(f * \phi)(v) e^{i x \cdot v} \mathrm{~d} x \mathrm{~d} \theta \\
& =s \int_{\mathbb{R}^{d}}\left(\int_{0}^{1} \nabla g(v-\theta x) \mathrm{d} \theta\right) \cdot \nabla \varphi(x) f(v-x) \mathrm{d} x \tag{94}
\end{align*}
$$

where $\varphi:=\mathcal{F}^{-1}\left\{\langle\cdot\rangle^{s-2}\right\}$. For the last equality in (94), we simply used the definition of convolution for the term $(f * \phi)(v)$.

Lemma 6.4. Let $d \geq 2, s \in(0,1], r \in\left(0, \frac{1}{2}\right), \alpha \in(0,1]$. Then, for any suitable function $f$, it follows that

$$
(1+(-\Delta))^{\frac{s}{2}}\left(f e^{r\ulcorner\cdot\rangle^{\alpha}}\right)=(1+(-\Delta))^{\frac{s}{2}} f \times e^{r \zeta \cdot \cdot)^{\alpha}}+\mathcal{R}(f) .
$$

The remainder term is controled by

$$
\|\mathcal{R}(f)\|_{L^{2}\left(\mathbb{R}^{d}\right)} \leq C(r, \varphi)\left\|e^{r\ulcorner\cdot\rangle^{\alpha}} f\right\|_{L^{2}\left(\mathbb{R}^{d}\right)} .
$$

Proof. Use formula (94) with $g:=e^{r \cdot \cdot\rangle^{\alpha}}$. The validity of such formula for this choice of $g$ is shown by standard approximation procedure. Note that, for $\alpha \in(0,1]$, one has $|\nabla g(v)| \leq r \alpha e^{r\langle v\rangle^{\alpha}}\langle v\rangle^{\alpha-1} \leq C e^{r\langle v\rangle^{\alpha}}$. Therefore,

$$
\int_{0}^{1}|\nabla g(v-\theta x)| \mathrm{d} \theta \leq C \int_{0}^{1} e^{r\langle v-\theta x\rangle^{\alpha}} \mathrm{d} \theta \leq C e^{r\langle x\rangle^{\alpha}} e^{r\langle v-x\rangle^{\alpha}}
$$

Thus, when $s \in(0,1)$

$$
|\mathcal{R}(f)(v)| \leq s C \int_{\mathbb{R}^{d}}\left|e^{r\langle x\rangle^{\alpha}} \nabla \varphi(x)\right|\left|e^{r\langle v-x\rangle^{\alpha}} f(v-x)\right| \mathrm{d} x .
$$

As a consequence,

$$
\|\mathcal{R}(f)\|_{L^{2}\left(\mathbb{R}^{d}\right)} \leq C\left\|e^{r\langle\cdot\rangle^{\alpha}} \nabla \varphi\right\|_{L^{1}\left(\mathbb{R}^{d}\right)}\left\|e^{r \cdot \cdot\rangle^{\alpha}} f\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}
$$

Note that $e^{r(\cdot \cdot\rangle^{\alpha}} \nabla \varphi \in L^{1}\left(\mathbb{R}^{d}\right)$ for $r \in\left[0, \frac{1}{2}\right)$. For the case $s=1$, follow the argument of Remark 6.1
